1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
4. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into

account for this criteria.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

##### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up

to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### **8.0 ELIGIBILITY CRITERIA-**

#### **8.1 DETAILS OF SUPPLIES MADE TO GOVT. DEPARTMENT / GOVT. UNDERTAKING**

The bidder shall submit statement containing details of manufactured, supplied and commissioned, minimum **01 No. of EOT Crane of 10 Ton Capacity or more** to Government Departments/ Undertakings/PSUs for each schedule. To meet this requirement, **the bidders shall submit copies of supply orders / invoices as a proof of supplies, issued in the name of OEM**, actually made. However, this condition shall not be applicable to those bidders who have already supplied **EOT Crane of tendered capacity (10 Ton) or more** to Irrigation Department U.P., but they are required to furnish the details as required under this clause and the firm has to submit the supply order / invoices. If firm has supplied lesser number of cranes to Irrigation Department U.P. firm would have to submit the supply order / invoices for rest quantity.

#### **8.2 PERFORMANCE CERTIFICATES IN RESPECT OF SUPPLIES REFERRED ABOVE**

The bidder shall submit performance certificates corresponding to the same supplies mentioned in "Supply Order Statement Annexure-A1" of satisfactory performance for a minimum period of **24 months** related to the supplies executed. The bidders shall submit details of Performance Certificates in the format annexed as "Performance Certificate Statement Annexure -A2" herewith.

The above conditions (8.2) shall not be applicable to the bidders, who have supplied the EOT cranes of required Capacity as mentioned in (8.1) to Irrigation Department, U.P. but they are required to submit invariably the details of supplies made to Irrigation Department, U.P. in Supply Order Statement, Annexure A1. The performance in such case shall be evaluated on the basis of their past supplies at the departmental level, in case performance of their past supplies is found unsatisfactory or unwanting, their Technical Part shall primarily be rejected on this ground alone and no further evaluation of Technical Part shall be done. Such bidder may also please note that their consideration in earlier tender shall not be a basis of their claim for consideration in the ensuing tender. If firm has supplied lesser number of EOT cranes, as required, to the Irrigation Department U.P., firm would have to submit the performance certificates of rest quantities of orders as mentioned in Annexure-A1.

#### **8.3 DETAILS REGARDING INFRASTRUCTURE FACILITIES**

- (i) Plants, machinery and other facilities at their works for manufacture of EOT crane of required capacity or more.
- (ii) Facilities available at their works for conducting tests of EOT crane of the required capacity as required in relevant IS.

**NOTE:** - Bidders may please note that if any of the preceding part of the tenders is not found responsive, the next part of the tender shall not be opened & no claim whatsoever shall be entertained. If the bidder fails to meet eligibility criteria such offer shall be non-responsive and rejected outrightly.

#### **8.4 OEM TURNOVER CRITERIA: -**

The minimum average annual financial turnover of the bidder and OEM during the last three years, ending on 31<sup>st</sup> March 2025 of previous financial year, should be as indicated in the bid document must be **Rs. 1.35 Crore or more respectively**. Documentary evidence in the form of certified Audited balance sheet of relevant period and a certificate for the chartered account/cost accountant indicating the turnover details for the relevant period should be uploaded with the bid otherwise their offer shall be rejected.

In case of date of certification incorporation of the OEM is less than three years old, the average turnover in respect of the completed financial years, after the date of constitution shall be taken into account for this criteria.

In case of the bunch bids, the OEM of category related to primary product having highest bid value should meet this criteria.

#### **8.5 OEM PARTICIPATION:**

**Only OEM of the offered product can participate in bid.**

Copy of Firm's industry registration and necessary information, as per clause 6.00 industry registration of ATC (additional terms and conditions) part-'D' Technical Conditions and Technical Specifications (Technical Conditions) must be uploaded.

**8.6** The Bidder should not be under liquidation; court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking to this effect with bid.

**8.7** Bidder's offer is liable to be rejected if they don't upload any of the certificates/ documents sought in the bid document, ATC and corrigendum if any.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.**

**However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.**
