AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

I. TERMS AND CONDITIONS:

- 1. Work completion Period:** The Vendor has to complete the Subject work within Three (03) month from date of handing over the site.
- 2. Warranty Period:** Vendor has to provide warranty period for 12 **month from date of completion.**
- The works is on **TURNKEY BASIS**. Any item, if required at the time of service execution is in Contractor scope.
- Quote should be valid as per GeM bid. Contractor may inspect the site before participation.
- All materials are to be entered at BDL Bhanur-CISF Gate/Township Security.
- The Engineers-in-charge for the subject work is Mr. Puneet Kumar Singh Mgr (PED) & Site-in-charge is Mr. Veera Kumar M, CE (PED-Elect).

7. This work cost includes packaging, freight, transport, insurance, fixing, testing & calibration etc.
8. Vendor may be called for Price Negotiation if required.
9. **Safety Terms:** While working on site, your personnel should follow all safety precautions with PPEs & any hindrance in the working area at BDL is not responsible for any accidents to your service personnel. Insurance & all other incidents are in your scope to the extent of his liability under workmen's compensation ACT 1923 & others. BDL is not responsible for any direct or indirect accidents to your service personnel. Vendor has to arrange all the necessary safety devices like Helmets, Safety Shoes etc. for carrying out the entire work.

II. PAYMENT TERMS:

1. 100% Payment will be made after receiving certificate from Site-in-charge and Engineer-in-charge with endorsement by the user about satisfactory work completion and submission of the following documents:
 - a. Original GEM Invoice and GST invoice with three copies.

L.D.Clause: If the Seller fails to deliver any or all of the Goods/Services within the original/re-fixed

delivery time-period(s) specified in the Contract, BDL reserves the right to deduct/recover from the

seller, the Liquidated Damages for the delay, unless covered under Force Majeure conditions afore-

said, @ 0.5% per week or part of the week of delayed period as pre estimated damages not exceeding

10% of the contract value without any controversy/dispute of any sort whatsoever.

2. BDL reserves its right to release GST only after supplier's invoice/debit note is reflected in GSTR-2B/2A within the specified time limit mentioned in GST law.
3. Invoice should contain GeM contract no, contract period, Description & Rates as per Contract order.
4. **Statutory deductions** as applicable will be deducted while releasing the payment.

III. SPECIAL CONDITIONS:

1. The contractor / Agency have to abide by the rules prevailing in BDL. The contra

ctor / Agency has to be engage skilled personal having required certificate.

2. The contractor shall possess and submit copy of valid 'A/B' Grade Electrical License, G.S.T /, P.F Code No., IT PAN, GST & ESI Registration No.
3. The tenders shall abide all the labour laws the state and the central government s in force. Contractor shall be responsible for all the consequence arising out of non-adherence by him of these to laws. Contractor shall be responsible for payment of compensation to his workmen employed on the job in case of accident.
4. Contractor / Agency have to make his own arrangements for accommodation for his workmen.
5. The contractor / Agency have to follow BDL security rules.
6. The contractor / Agency shall be responsible for execution of work safely. Safety of machinery, personnel working shall also the part of contractor's responsibility.
7. The contractor / Agency shall make his own arrangements for all the material, tools, Ladder,tackles and labor required for the work. Premises to be cleaned after completion of the work.
8. Contractor / Agency requested to inspect the site thoroughly before quoting for each item in the tender schedule.
9. Sample of all the materials shall be approved by the BDL before use.
10. All debris material generated should be disposed within the factory premises (Scrap yard) or as directed by E.I.C. Scrap Depot Challan to be filled and submitted.
11. The works should be executed without disturb / damaging the existing water line, electrical / Tele Phone cables. If it gets damaged during execution of work, same has to be repair/replace the items of water pipe/Electric cable etc., on their own cost. Otherwise equivalent repair cost amount will be deducted from their final bill. Roads have to be maintained as it is before the execution/ road cutting & filling by proper required road material. Road pieces /cracks are not considered.
12. Material brought for work must be entered in CISF / BDL security register.
13. Contractor has to make his own arrangement for lighting if required.
14. No material will be issued by BDL.
15. Contractors are required to comply with the provisions of ESI & PF act.
16. Contractor has to take the insurance for the workers engaged for the work.
17. As BDL is ISO-14001:2004 (EMS) certified company; contractors are requested to follow the EMS norms.

18. All the accessories like nut, bolts, clamps any other accessories material required for fixing of water heater / other items is in the contractor's scope.
19. The works shall be completed as a whole, Partial value/completion is not considered.
20. Contractor has to take necessary pass for their men from security personnel. Engaged workmen have to wear Safety jacket along with Identity card for Identification. Contractor has to maintain necessary record/register for details of their men and their Entry/Exit to BDL Premises during execution and the same to be submitted along with Invoice.

IV. **ELEGIBILITY CRITERIA**

1. The bidder has to submit the proof of experience of having successfully completed similar works in CPWD, MES, P&T, Railways, Defence and other Govt. Department, state PWD, CSIR or any of its laboratories, reputed Private sector and joint venture with multinational companies, during last 7 years ending 31st March 2026.
 - a. Three similar completed works costing not less than Rs. 3.85 Lakhs Each
'Or'
 - b. Two similar completed works costing not less than Rs. 4.81 Lakhs Each
'Or'
 - c. One similar completed work costing not less than Rs. 7.71 Lakhs. Each
2. In case of experience certificate obtained from reputed organizations the same shall be supported with TDS certificate by the contractor.
3. Similar work means: Internal Electrification/ External Electrification
4. Availability of office of service provider: An office of the service provider must be located in the state of consignee. Documentary evidence to be submitted.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
