**Manufacturer Authorization:**Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

### 7. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

### 8. **Turnover**

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. ### **1. Bid Brief:**

1.1 The Directorate of Information Technology, Govt. of Tripura on behalf of Tripura Police, Home Department, Govt. of Tripura through this tender intend to invite reputed OEM/ authorized supplier/ distributor/ Seller for Supply, Installation, Training (wherever required) and Commissioning of IT hardware under ICJS 2.0 Project.

1.2 The bidder shall be solely responsible for supplying the actual product conforming to the specifications laid down in the ATC and ensuring full compliance with the requirements of the ICJS 2.0 project in Tripura.

1.3 The bidders shall provide ITR for the last 3 (three) consecutive Financial Years.

### **2. Instructions to Bidders for Online Bid Participation:**

2.1 All Bid documents can be downloaded free from the GEM Portal.

2.2 All bids should be submitted online through the GEM Portal.

2.3 The detailed required specifications of the equipment to be purchased are shown in Technical Bid. The bidder should either confirm whether the items offered are conforming to these specifications clearly **OR** specifications available in the offer product should be shown against each specification along with the name of manufacturers, Brand/Model only in the format provided in technical bid.

2.4 The bidder should have to arrange a demonstration of equipment offered as and when desired at O/o the DIT Tripura, Agartala, West Tripura at their own expense failing which Bid shall liable to be rejected. In case where samples are required to be submitted, it should be kept ready and submitted at their own expense as and when demanded in duly sealed pack superscripted with details of Bid enquiry No, Due Date, Name and address of bidders, Make/Model etc. failing which offer shall liable to be rejected.

2.5 No conditional offer/ quotation will be accepted. Quotations with errors will be rejected. No variation in the terms and conditions of the tender including major deviation from standards/ specifications/terms of supply will be accepted.

2.8 The bidder must not have been declared insolvent/ bankrupt or should not have filed for insolvency/bankruptcy or in the process of being declared bankrupt before any designated authority. A Self Declaration regarding the bidder not being, or not having filed, or is not in the process of being declared, insolvent/ bankrupt shall be submitted.

2.9 The bidder should not have been blacklisted by any of the State/ Central Government or organizations of the State/ Central Government in India in the past three years. **Self-Declaration in this regard by the authorized signatory of the bidder to be submitted.**
