d) **EARNEST MONEY DEPOSIT/E-PERFORMANCE BANK GUARANTEE (E-PBG)**: DGR sponsored ESM are not required to deposit Earnest Money Deposit (EMD). OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
