1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and

based on competitive prices received in Bid / RA process.

OPTION CLAUSE 50% : The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 50 percent with the consent of the service provider

**2. Buyer Added Bid Specific ATC**

### Buyer Added text based ATC clauses

1. on non-satisfactory service performance or non-compliance of any terms and conditions of the contract or any other reason as decided by competent authority, the contract may be terminated with an advance notice of 60 days from buyer side.
2. The contractor shall ensure that its personnel shall have identity cards, provided by the contractor which shall be worn in such a way that it is prominently displayed and visible so that any person can identify the individual representing the contractor.
3. The personnel shall attend to work punctually at the prefixed/ determined timings and shall be well-behaved and mannered.
4. The personnel should be provided with two set of uniforms and they are to wear uniform attire daily without fail. The cost of the uniform should be borne by the contractor.
5. The personnel shall perform all the duties assigned to the contractor and as specified by the respective HODs/ Head of Office/AOs/Officers from time to time.
6. The contractor is responsible for payment of salary to the personnel employed. Also, if there is any change in the minimum wages or any statutory wage component as per the Applicable Laws during the Contract period, the differential amount will be paid by the service provider and copy of such change should be submitted to the Buyer while submitting the bill.
7. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.
8. Duration of the service contract may be extended beyond the initial contract duration as per GeM rules in force. (subject to satisfactory performance and mutual consent).
9. Contractor shall ensure that the invoice is raised in the name of consignee with GSTIN of Consignee only.
10. The contractor shall ensure that the work undertaken by its personnel is carried out efficiently and to the satisfaction of HODs/Head of Office/Administrative Officers.
11. The contractor and the employees engaged by the contractor shall be subject to the entry and exit procedures of the Department as may be determined by the Department from time to time.
12. If in the opinion of this office, the contractor engages inadequate number of employees or does not execute the work in a satisfactory manner or in accordance with the terms and conditions of the contract, the Commissioner of Income Tax (TDS), Coimbatore may get the work done through a third party contractor, without any written notice to the contractor, the cost of which shall be recovered from the contractor.
13. Undertaking with regards to non-blacklisting, no-bankruptcy, nonliquidation as required by ATC must be as on date of submission of bid. Date must be mentioned clearly in the undertaking.
14. The bidder should have registered/branch office at Coimbatore district in Tamil Nadu and documentary evidence should be submitted.
15. NET WORTH: Net worth of the contractor should be positive as per the last audited financial statement.
16. Bidder should have [ISO:9001](#) Certificate.
17. The bidder should be in possession of requisite license/certificates which are required by regulatory authority for providing of services required in BID document. copy of the same to be uploaded while applying for the BID.
18. on successful awarding the contract the selected bidder within a month of contract award has to furnish, Bio-data, and police verification report of the person being deployed.
19. Bidder also required to submit an advance notice of 60 days, if bidder wants for termination of contract.

### 3. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar

proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

#### 4. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

#### 5. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

#### 6. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

#### 7. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

#### 8. **Service & Support**

The Service Provider is required to have at least 40 % of the required manpower on service provider's payroll for at least one year. Necessary documents relating to such manpower will be uploaded by the bidder for verification of the buyer. Such manpower will be part of total manpower to be provided by the Service Provider in case he gets the contract against this bid.

#### 9. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 10. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

#### 11. **Past Project Experience**

**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. ### Scope of Work:

1. To provide security services for the protection property against theft, safety to manpower and guiding visitors to the concerned place of visit.
2. Evacuation of occupants in case of the fire or natural calamities.
3. Prevention of entry of unauthorized personnel in the office premises.
5. The Security personnel must have the contact details of the emergency services nearest to the office premises (police station, Fire Station, Ambulance) in case of emergencies, if any.
6. The security should maintain and ensure security at the entrance gate by regular check of incoming/ outgoing visitors.
7. The Security personnel should maintain a visitors' register and insist they write in the register their Name, Address, Telephone number, purpose of visit and the person they intent to meet.
8. Ensuring that Visitors' Vehicle should be parked at designated places.

All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.

11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1

bidders through a Random Algorithm executed by GeM system.

14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
