If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 4. 5. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

Special terms and conditions-Version:1 effective from 05-12-2025 for category Wheeled Fire Extinguishers (V3) ISI Marked to Is 16018

1. This category is BIS Scheme - 1 compliant. Catalogs must have valid and active CM/L license number owned by the applicant themselves. In case of non-compliance, appropriate action may be taken against OEM / Brand / Seller as per the GeM IM Policy.

The gas shall be supplied compressed in Cylinder. The design of the Cylinder, pressure of gas in Cylinder, packing, marking, painting, labelling, storage and transport of Cylinder shall be in accordance with the Gas Cylinder Rules , with such modifications as may be ordered from time to time by the CIE, PESO, DPIIT, MoC&I, Gol.

1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. **Warranty**

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

3. **Buyer Added Bid Specific ATC**

1. Liquidated Damages: The Delivery Date stipulated in this order is the essence of the Contract. You should adhere to the delivery schedule as stated above and execute the order before the stipulated date. In case of delay, Liquidated damages @ 0.5% (Half Percent) of the value of undelivered portion per week or part thereof, Subject to a maximum of 10% of the total contract value will be levied.
2. LAND BORDER : The bidder shall provide compliance to Order No.F.No.6/18/2019 PPD, dated 23.07.2020 and amendments thereof by Ministry of Finance, Department of Expenditure, Public Procurement Division regarding restrictions on procurement from a bidder of a country which shares a land border with India and comply to all the provisions of the Order. In this regard, you shall certify that the bidder entity is not from such a country or, is from such a country, has been registered with the competent Authority.
3. Make-in-India (MII) clause:For this procurement, provisions contained in public procurement (preference to make in india), order 2017 issued by department for promotion of industry and internal trade (dpiit), ministry of commerce & industries vide letter no. p-45021/2/2017-pp(be-ii) dated 16.09.2020 & directives related shall be followed. accordingly, you are requested to indicate the percentage of local content in the material, clearly mentioning the details of location(s) at which value addition is made in line with clause 9 to o.m dated 16.09.2020 referred above. it may be noted that local content shall not include services such as transportation, insurance, installation, commissioning, training and after sales service support like amc/cmc etc.
4. FORCE MAJEURE :If any time during the currency of the order, the performance to whole or in part by either party of any obligation under this order shall be prevented or delayed by reasons of any war, hostility, acts of public enemy, civil commotion sabotage, fire, floods epidemic, quarantine, restrictions, strikes, go-slow, lockout or acts of god, notice of which given either party to the other within 21 days from the date of occurrence then neither party shall be reasons of such eventuality be entitled to terminate this order nor shall either party have any claim for damages against the other in respect of such non-performance or delay in performance.
5. Items will be inspected by the Department after the delivery at site. If it is not found in appropriate condition or it is from the old stock or fails to meet the desired specifications, Item will be rejected. Subsequently, the supplier has to replace the item with a new batch at the supplier's cost.
6. Items shall be delivered on working days only (Monday to Friday) excluding Public Holidays and during working hours (from 10:00 AM to 04:00 PM)
7. Authorization Certificate from OEM should be attached along with offer, if vendor is not OEM.
8. Please provide compliance to all the terms and conditions, Technical Specifications, mentioned in the GeM bid specification document along with documentary evidence duly filled and signed as a token of acceptance for the same. otherwise your bids are liable to be rejected.
9. Bidders must fill up all the schedules and annexure and furnish all the required information as per the instructions given in various sections of the tender specification. Each and every page of the tender specification must be SIGNED AND SUBMITTED ALONG WITH THE OFFER by the bidder in token acceptance thereof. The information furnished shall be complete by itself.

10. Price of any Kind shall not be disclosed in the technical bid otherwise the offer will be summarily rejected.
11. All Terms & Conditions are as per the Specification document attachment.
12. Payment Terms: Payment will be made within 30 days of receipt and acceptance of the ordered items at our site.
