Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
3. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Generic

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

2. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

3. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Bid Schedule

- 1.1. The bid opening and closing period shall be 10 days.
- 1.2. The bid cycle (validity period from the date of publishing) shall be 85 days

2. Eligibility of Bidders

- 2.1. The bidder must be a registered legal entity in India and must possess valid registration with the tax authorities.
- 2.2. The bidder must attach copies of valid PAN and GST registration certificates with the bid.
- 2.3. The bidder must have a geographical presence in the state of consignee i.e. Chandigarh. The Firm should have registered address of Chandigarh. In support, the bidder shall submit any one of the following: GST registration certificate at Chandigarh, or Registration with EPFO/ESIC at Chandigarh.
- 2.4. Bids submitted under Rent Deed shall not be accepted

3. Statutory Compliance and Affidavits

- 3.1. The bidder shall upload an undertaking in the form of an affidavit, or a certificate from the competent authority, confirming non-default in the deposit of statutory contributions such as EPF, ESI, and GST during the last three financial years.
- 3.2. The bidder shall submit a duly attested affidavit (by an Executive Magistrate) declaring the following:
 - 3.2.1 That the bidder/service provider has never been declared bankrupt, insolvent, or placed under liquidation by any financial institution or court of law.
 - 3.2.2 That the bidder/service provider has an unblemished record and has never been blacklisted by any Central/State Government, PSU, University, Educational Institution, or any court of law
 - 3.2.3 That no criminal, civil, or legal proceedings are pending or registered against the bidder/service provider.
 - 3.2.4 That the bidder accepts all terms and conditions of the tender, including these Additional Terms & Conditions and the Scope of Work.
 - 3.2.5 THAT I/WE UNDERTAKE THE COFIRM THAT ELIGIBLE SIMILAR WORKS (S) HAS/HAVE NOT BEEN EXECUTED THROUGH ANOTHER CONTRACTOR ON BACK-TO-BACK BASIS. FURTHER, IT IS UNDERTAKEN THAT IF SUCH A VIOLATION COMES TO THE NOTICE OF ENGINEERING DEPARTMENT CHANDIGARH ADMINISTRATION,

THEN I/WE SHALL BE DEBARRED FROM TENDERING IN ENGINEERING DEPARTMENT, CHANDIGARH ADMINISTRATION IN FUTURE FOREVER. ALSO, IF SUCH A VIOLATION COMES TO THE NOTICE OF ENGINEER 10 / 13 I NG DEPARTMENT, CHANDIGARH ADMINISTRATION THE ENGINEER-IN-CHARGE SHALL BE TREE TO FORFEIT THE ENTIRE AMOUNT OF PERFORMANCE GUARANTEE DEPOSITED BY ME/US.

4. Experience and Financial Criteria

- 4.1 The service provider must have a minimum of three (3) years of experience in providing manpower services.
- 4.2 The bidder shall attach a certificate from a statutory auditor/Chartered Accountant (CA) indicating the average annual turnover for the last three financial years (2022-23, 2023-24, and 2024-25), which shall be as per the requirement specified in this bid document.
- 4.3 The bidder must possess a valid ISO Certification.
- 4.4 The bidder must also submit a valid Labour Department Registration Certificate (Form-F) issued by the Labour Department, Chandigarh.

5. Duration and Extension of Contract

- 5.1 The total duration of the service contract shall be as specified in the bid document.

5.2 The contract may be extended for a further period of up to one (1) year beyond the initial contract period, subject to satisfactory performance and mutual consent of both parties.

6. Payment and Wage Disbursement

6.1 The service provider shall be responsible for timely payment of wages to the deployed contractual staff as per applicable DC rates fixed by the Chandigarh Administration from time to time

6.2 Payment of wages must be accompanied by statutory compliance documents such as EPF, ESI, and GST challans.

6.3 The service provider must submit a bank statement showing salary disbursement to the deployed staff before the 7th of every month.

6.4 Bills for payment shall be raised only after submission of proof of wage disbursement and statutory payments.

6.5 The service provider shall be solely responsible for the timely deposit of statutory dues (EPF, ESI, GST, etc.) and any penalty for late submission shall be borne by the contractor.

6.6 Applicable TDS deductions under the Income Tax Act and GST Act shall apply.

6.7 Payment of wages to workers shall not be linked to the release of pending bills by the Department. The service provider must have sufficient funds to cover at least three months salary of the deployed staff in advance without payment being released from department.

7. Deployment of Existing Resources

7.1 The number of existing manpower deployed under the current contract shall continue under the new contract, subject to their willingness to work under the revised terms and conditions.

7.2 The service provider shall not replace existing staff without prior written consent of the Buyer/ Department.

8. Variation in Quantity

8.1 The purchaser reserves the right to increase or decrease the required manpower by up to 25% during the contract period.

8.2 The bidder shall be bound to accept such variations on the same terms and conditions.

9. Employee Documentation and Identification

9.1 The educational qualifications of outsourced manpower shall conform to the minimum qualifications (Which is Middle School/High School in this case) applicable on their original date of joining.

9.2 The service provider shall furnish complete employee documentation, including educational certificates, Aadhaar card, PAN card, etc., at the time of deployment.

9.3 The ID cards of all deployed staff shall be issued by the service provider at its own cost. No reimbursement or claim for ID cards shall be entertained by the Department.

10. Blacklisting and Penalties

10.1 The purchaser reserves the right to blacklist the firm for a period of up to three (3) years in case of failure, default, or breach of contract terms and conditions.

10.2 A reasonable opportunity of hearing shall be provided to the bidder before issuing any blacklisting order.

11. Precedence of Conditions

11.1 In the event of any conflict between the GeM portal in-built terms & conditions and these Additional Terms & Conditions, the Additional Terms & Conditions (ATC) shall prevail

12. Agency shall not demand any payment, registration fee or any kind of extortion from the employees deployed under this contract.

13. The Bidder should have a PASRA Certificate issued from Chandigarh Administration.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or

notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and
- All operative provisions of the erstwhile Labour Laws until their complete substitution.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
