7. 8. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 9. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are

validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

10. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

11. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.

##### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to

minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. **Buyer Added Bid Specific ATC**

### ADDITIONAL TERMS AND CONDITIONS

1. Buyer reserves the right to cancel the bid any time without assigning any reason.

2. Bidder should upload one certificate to include the additional terms and conditions (ATC) stating that seller is accepting all terms and conditions, specification parameters mentioned for the bid. If a bidder didn't upload this certificate, the bid will be summarily rejected during technical evaluation with /without assigning any reason.

3. To get the purchase preference in MSE/MII (First Class Supplier) category, Bidder is required to apply in the same category on GeM and to upload relevant certificates issued by the appropriate authority while participating in the Bid. No purchase preference will be awarded in case of non compliance of above.

4. Successful bidder will have to deposit performance security within 7 days from the date of award of the contract.

5. Bidder has to furnish quality certificate from approved Govt. / Govt. recognized Lab. In case of deviation noticed in quality inspection, 10% penalty will be imposed.

6. Successful bidder will supply only OEM make Original item. Buyer will have the right to send Random samples out of the supplied product to OEM to confirm the genuineness. If not found genuine then 10% penalty will be imposed on the amount.

7. Bidder has to supply the whole quantity within the stipulated time and at venue mentioned in Bid. Delay in supply will attract LD a sum equivalent to 0.5 (Half) percent of the prices of any portion of stores delivered late, for each week or part thereof of delay as per General Terms and Conditions of GEM. The calculation will be done for the whole of the week or part thereof

8. Delivery Schedule shall be as given above, the whole quantity are required to be delivered within 30 Days from the date of issuing the purchase order

9. Payment for the purchase would be made only after successful completion of contract and subject to availability of funds.

10. Supply and transportation: Seller will arrange to dispatch the material through their authorized transporter on door delivery basis. Loading and unloading of material shall be in scope of seller (including all taxes).

11. Material Inspection will be done only after completion of whole supply. In case of more than one material inspection are to be done due to operational requirement of department 1% penalty may be imposed on su

pplier.

12. Rejection of material:

a) If the delivered product/ part of product are not found according to requisite quality/ specifications then the product/part of product will be confiscated / replaced.

b) If the Material supplied do not confirm to the specification laid down in the tender the Department reserves the right to reject the material. For the rejected material, no payment will be made and the supply will be confiscated / replaced.

c) In addition, in the event of delivery of any defective/sub-standard supply, which owing to urgency or for any other reason cannot be wholly rejected, the Department shall have the power to deduct from any payment due to the supplier such amount as penalty subject to maximum penalty of 20%. If required, testing can also be done through Govt. Lab. In case, the material found sub standard/defective, the cost of testing fee will be borne by the supplier firm.

13. Payment of the supplies will be made on completion of total quantity and after necessary material inspection approved by competent authority.

14. After issuing of purchase order to the approved bidder if he fails to execute the supply order or deny supplying the ordered quantity, in such case the Department shall recommend to GeM for debarring such bidders from participation in the bids at least for one year. In addition if the approved bidder accepts the extended bid offer validity after its expiry and fails to execute the purchase order issued to him, it will also be liable to be recommended for one year debarment by GeM apart from other action as prescribed in GFR 2017 and other relevant procurement rules issued by Government from time to time.

15. Product should be of recycled material to make it Eco friendly.

16. All disputes and proceedings arising out of or relating to contract/bid shall lie only in the Delhi jurisdiction

4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.

If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**
