1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the

Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 4. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

4. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

6. **Inspection**

Manufacturer Authorization: Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

10. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

11. Warranty

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 3 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

12. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

(A). The offered item shall be considered proven provided it meets Technical Proven-ness criteria noted below, otherwise the offer shall be liable for rejection. ECL's decision to consider any firm as proven will be final and binding upon the tenderers.

Proven-ness Criteria:

Credential of Same and Higher Specifications items supplied within 5 years from the date of Tender opening (Along with PO copy & copy of invoice/challan for supplies made to ECL/CIL or its subsidiaries/ Other PSUs/ Government organizations), and these items have performed satisfactorily.

Documents to be submitted:

i. Self-certified copy of past supply order in respect of tendered items received during last five years to ECL/ CIL or its subsidiaries/Other PSUs/Government organizations, as mentioned above.

ii. Self-certified copy of Proof of supply made against the supply order submitted such as self-certified copy of delivery challan/invoice/e-way bill etc.

iii. Performance Certificate:- Satisfactory Performance report against the supply order submitted as per clause (i) above and in manner as indicated below.

iii(a). In case copy of supply order submitted is of ECL, Kunustoria Area then bidder need not to submit satisfactory performance report, HOD (Technical) shall certify whether the performance was satisfactory.

iii(b). In case copy of supply order submitted is/are of other Areas of ECL/ CIL or its subsidiaries/ Other PSUs/ Government organizations then bidder should submit self satisfactory performance report from the concerned Area/Subsidiaries/ CIL / Other PSUs/ Government Organization.

Note: The Bidder shall be exempted from Proven-ness criteria if:

(i) The Bidder were a Rate Contract holder as issued by CIL or CIL Subsidiary Companies for the tendered items within last 05 years.

(ii) The Bidder Has a valid DGMS approval/ BIS certificate license for the quoted item.

(iii) The Bidder Proven Ancillary certificate issued by Subsidiary Companies for the quoted items on them.

Note: - ECL may prefer the vendors to have prior experience rather than giving orders to new entities for procurement of items related to public safety, health, critical security operations and equipment, etc. in line with clarification given by the Department of Expenditure, MoF vide OM No. F.20/2/2014/PPD-(Pt) dated 20.09.2016.

(B). Guarantee/Warranty: The materials shall be guaranteed for a period of 12 months from the date of installation or 18 months from the date of supply against any manufacturing defects/bad workmanship/premature failure. In case of any manufacturing defects/bad workmanship/premature failure the supplier should replace the material at free of cost within 30 days from the date of intimation.

(C). Declaration:- The bidder has to give declaration that they have not been banned or de-listed by any Govt. Or quasi Govt. Agencies or Public sector Undertakings. This fact must be clearly stated.

(D). E.C.L reserves the right to accept or reject any or the entire offer, extend tender opening, modify tender document or cancel the tender at any stage of BID/tender without assigning any reason. The offer should be submitted strictly as per the terms & conditions laid down in the tender document, failing which the offer may be liable for rejection.

(E). Identification marking: The materials to be supplied must have the manufacturer's identification mark engraved/embossed on non-wearable portion failing which the Consignee will not accept the material. Where embossing / engraving is not possible manufacturer's identification should be either by painting or by the manufacturer's sticker. The tenderers should accept this clause and mention in their offer.

(F). Fitment Guarantee:- The materials must fit into the equipment for which it is being purchased without any modification otherwise it would be rejected. The tenderer may visit the site before submitting their offer.

(G). Price Fall Clause: The Bidder undertakes that it has not offered to supply/ supplied /is not supplying same or similar product/systems or sub systems at a price lower than that offered in the present bid in respect of any Organization / Ministry / Department of the Govt. of India or Coal India Ltd. and/or its Subsidiaries or other PSU or any other private organization during the currency of the contract and if it is found at any stage that same or similar product/systems or sub-systems was supplied by the bidder to any Organization / Ministry/ Department of the Govt. of India or Coal India Ltd. and/or its subsidiaries or other PSU or any other private organization at a lower price during the currency of the contract, then that very price will be applicable to the present case and the difference in the cost would be refunded by the bidder to buyer, if the contract has already been concluded.

a. The currency of contract will mean the period till completion of supply.

b. The bidder shall have to submit a copy of the last (latest) purchase order for the tendered /similar item(s) received by them from any Organization / Ministry / Department of the Govt. of India or Coal India Ltd. and/or its Subsidiaries or other PSU or any other private organization, along with the offer.

c. It shall be responsibility of the supplier to inform the purchaser of offer to supply / supply of the ordered / similar item(s) at a lower rate to any Organization / Ministry / Department of the Govt. of India or Coal India Ltd. and/or its Subsidiaries or other PSU or any other private organization during the currency of the contract.

d. The successful supplier shall submit a certificate along with the bill(s) that *"It has not offered to supply/supplied the ordered / similar item(s) at a lower rate to any Organization / Ministry / Department of the Govt. of India or Coal India Ltd. and/or its Subsidiaries or other PSU or any other private organization."*

This certificate shall also be submitted with the offer.

(H). Additional Doc 1: Bidder has to submit a self-certificate in the following format:- " The items covered in the Purchase order(s) / Rate contract (s) copies enclosed with our offer have been fully executed and have performed satisfactorily as per the provisions of respective purchase order (s) / Rate contract(s) and all the complaints/claim(s) lodged by the purchaser, if any have been attended to and no complaints/claim (s) are pending."

(I). TReDS: Trade Receivables Discounting System (TReDS) is an initiative of the Reserve Bank of India (RBI) to facilitate MSME receivable payments from corporates.
