4. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 1. Scope of standard installation and commissioning for Wall Mount Split AC consist of follows:

- Installation/Commissioning is mandatory for all types of purchases (Direct/L1/Bid). For cases where Installation/Commissioning is not required, the buyer may indicate the details in the bid document.
- The Switches/ Sockets/ Plug Tops/ Voltage Stabilizer/stand for ODU/ Chiselling/ Ducting/ Grooving for concealing the refrigerant piping/cabling/ core cutting of the wall are not included in the scope of standard installation and commissioning, unless otherwise mentioned in the contract.

Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG).Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

29. Past Project Experience

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Any other document in support of contract execution like Third Party Inspection release note, etc.
Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. 30. Past Project Experience

The Bidder / OEM {themselves or through reseller(s)}, should have executed project for supply and installation / commissioning of same or similar Category Products during preceding 3 financial years (i.e. current year and three previous financial years) as on opening of bid, as per following criteria:

- (i) Single order of at least 35% of estimated bid value; or
- (ii) Two orders of at least 20% each of estimated bid value; or
- (iii) Three orders of at least 15% each of estimated bid value.

Satisfactory Performance certificate issued by respective Buyer Organization for the above Orders should be uploaded with bid. In case of bunch bids, the Category related to primary product having highest bid value should meet this criterion

1. The OEM Should have Valid ISO 9001 & ISO 14001 certification, the same must be submitted by the Bidder
2. The OEM should not be a blacklisted/debarred company by any Government Department /Financial Institution/ Public sector Units/Scheduled Commercial bank in Ind

- ia. Declaration of the same to be submitted. (The OEM should give the declaration in their company letter head).
3. Only authorized dealer of Original Equipment Manufacturers (OEM) are eligible to participate in the Bid. (Authorization letter should be enclosed in OEM letter head).
 4. The supplier/OEM should have an office/service set up in Madurai District to enable speedy and quick response for our service requirements. The bidder should furnish the details of the OEM authorised service centre with address and contact details in OEM/supplier letter head.
 5. The bidder should have supplied and installed atleast **300 No.** of Air Conditioners in each of the previous 3 financial years. Documentary Proof to be submitted in this regard.
 6. The annual turnover of the supplier should be above **Rs. 1.00 crore** for each of the previous 3 financial years and annual turnover of the OEM should be above **Rs. 1000.00 crore** for each of the previous 3 financial years
 7. The excel sheet uploaded by the buyer should be filled and submitted by the bidder mentioning the price of the items described in the sheet.
 8. The BANK is not responsible for the breakage/damage of any goods during the transit. In that case, it is the responsibility of the firm/bidder to whom the work has been awarded to replace the damaged goods.
 9. During installation, if any of our Bank asset is found to be damaged, bidder should arrange to rectify/replace the damage occurred at bidder's cost. Failing to which the cost will be recovered from the invoice amount.
 10. The delivery and installation should be done at the branches of Madurai and Virudhunagar District as specified by the buyer.  13. 20% of payment which includes the Installation Charges in Order value (Inclusive of GST) shall be made after Successful installation of Air conditioner units at the said branch premises. Payment shall be released by bank's Regional Offices on su

Submission of installation and warranty certificate signed by authorized official of the Bank / Branch with Date and seal of the Bank Branch.

14. Four Free Maintenance Services should be provided once in three months during the warranty period and balance payment of 5% of the order value (excluding GST) will be paid after submission of Four Original Sets of Service Reports and proper functioning of each AC Units during the warranty period of one year duly produced with service report with Branch Manager's Signature and seal with date. In Case, the successful bidder is unable to submit all service reports and if any AC units & its accessories are not working then the entire Balance Amount i.e. 5% of the order value will be penalized.
15. Warranty period for the compressors should be minimum of 120 months (10 Years), Printed Circuit Board (PCB) should be minimum of 60 months (5 year) from the date of completion of installation and for other related spares of air-conditioner unit it should be minimum of 12 months (One Year) from the date of completion of the installation.
16. In warranty period, its covering all parts, maintenance / support for its proper operation, performance for a Period of 12 months (One Year) from the Date of satisfactory operational of Machines and Certified by the Branch in Charge in writing.
17. During the said warranty period of 12 months, the bidder shall without any extra cost, carry out all routine and special maintenance of the AC units and attend to any difficulties /defects / replacements that may arise in the operation of the system. There should be regular preventive maintenance at least once in three months.
18. In case of any deficiencies noticed due to poor workmanship, during Warranty period, the same should be replaced or rectified free of cost by the L1 Bidder at their own cost and risk.
19. The defective or replaced parts shall be returned to the Bidder upon request and at his cost and responsibility. The Bank will, however, render such assistance in the matter as will expedite the same.
20. If the Bidder on account of the defects and/or repairs replaces certain items by changing the design or materials, such change shall not reduce the performance of the equipment as per the technical specification.
21. If the bidder does not rectify either by repair or replacement, such defects and put back the machine into satisfactory operation within 10 working days from the date of notice by the Bank, then the bidder shall arrange for a standby machine.
22. Four Mandatory visits during the year (One visit in every quarter) will be done by the bidder for the purpose of ensuring the maintenance of the Air Conditioner. The bidder will maintain a data log sheet of all Air Conditioners like location, type and due date for visit etc.,
