1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. **3.) Acceptance Criteria at IPR:**

1. Acceptance will be given only after successful completion of the installation, testing and training at IPR.

2. Installation, testing and training to be done by Vendor.

3. During installation and testing Bandwidth, Sampling, Record length, Noise floor and Vertical bit resolution should be tested as detailed in the specification. IPR representatives will witness the same.

(3.1) Bandwidth shall be tested using a function generator with the maximum frequency of the oscilloscope mentioned in the specification. Vendor should bring the function generator for testing of the oscilloscope.

(3.2) Sampling rate shall be determined from the ratio of the record length to the acquisition time window. By measuring the number of stored data points and the total time span of the waveform, the effective sampling rate for 4 channel simultaneously tested for the tender parameter.

(3.3) The record length shall be tested for different time per division of the scope and storing the data to check the record length.

(3.4) Noise floor shall be tested with proper termination without any external hardware or cable. The RMS value of the measured voltage fluctuation will be used for estimating the intrinsic noise level of the instrument.

(3.5) Vertical bit resolution shall be tested by giving a very slow ramp signal to the oscilloscope with small amplitude and high record length.  $2N = V_{range}/LSB$ ;  $V_{range} = (\text{Volts/div}) \times (\text{number of vertical divisions})$ , LSB is the smallest voltage increment between adjacent points.

4. OEM/representative should provide a detailed Demonstration and Training of the Equipment at Institute for Plasma Research, Gandhinagar.

**4.) NOTE:**

**In the main specification of attached Compliance Sheet, under technical parameter no: 5, 9, 10 and 17, mentioned value or higher would be acceptable and under parameter no: 13, mentioned value or lower would be acceptable.**

## 5.) RECTIFICATION AND REPLACEMENT OF DEFECTIVE STORES:

In case repair/replacement of defective/rejected stores during warranty period is necessary and becomes essential to return the stores, to the contractor, where full or part payment has already been made by the purchaser, the contractor shall submit bank guarantee for the value of stores so found defective/rejected as per **Annexure-III** valid till receipt and acceptance of repaired/replaced/entire stores within fifteen days of intimation to collect the stores.
