TERMS & CONDITIONS OF CONTRACT -- For Repairing &overhauling of 145 KV circuit breaker (CGL make) installed at HV side of 20 MVA T/F Ist at 132 KV Modisteel under ETD Muradnagar

1. Scope of Work: -

Work of replacement of damage parts at various tower location no at 220/400 kv line under ETD muradnagar

2. T & P: -

All T & P required for proper execution of works shall be arranged by the contractor himself, at his own cost. However, any special T & P as specified in contract and necessary for completion of work can be had from the Dep. On request free of charge. But non availability of any such T & P shall not absolve the contractor of his responsibility to complete the work. No extra payment shall be made on account of this.

3. LABOUR: -

Sufficient Mechanic/skilled labours shall be arranged by the contractor at his own cost. In this connection department does not take any responsibility. However, if at any stage it is found the proper skilled personnel have not been deployed by the contractor for the work, he has to withdraw the unskilled labour doing the skilled job and deploy skilled personal meant for doing the job. Also, the person deployed by the contractor found including in this the act of union, indiscipline or anything objectionable, shall be removed from site if asked to do so by engineer.

4. ELECTRICITY RULE: -

All construction work shall be carried out as per relevant provision of Indian Electricity rule 1956 and Indian Electricity Act. 1910 or any amendment there of technical specification of the contract any other manual referred to therein shall be strictly adhered to.

5. SAFETY & WORKMANSHIP: -

All safety rules shall be strictly observed by the contractor during the entire period of execution of work. However, in case of any major or minor accident, the contractor shall be wholly responsible for all consequences arising there of including payment of compensation under "Workers" compensation Act and the department shall in no way be responsible of this JE & AE shall ensure that at no level the safety ruled is violated.

6. MATERIAL: -

All material shall be provided by the contractor at his own cost.

7. THEFT & LOSSES: -

In case of any theft and losses of material, reported by security guard/Contractor, necessary FIR shall be lodged by concerned JE with the concerning Police Station.

8. INSURANCE: -

The responsibility to maintain adequate insurance coverage at all times during period of contract for safety of staff deployed and spares handed over for maintenance shall be that of contractor. The contractor shall also take necessary insurance to indemnify third party risk arising out of work to be done by him at his own cost. The department shall not be responsible in any way in case of any mishappening. The contractor shall provide with copy of all insurance policies & documents to Executive Engineer.

9. SUPERVISION: -

All work shall be supervision by Assistant Engineer/JE shall be over all in charge of supervision of each & every work in the contract. JE entrusted to get the work done, shall personally ensure that the execution is done exclusively as per specification of contract. In case of any deviation, he will immediately write to contractor under intimation to Assistant Engineer/Engineer in Charge.

10. ENGINEER: -

Executive Engineer, Electy. Transmission Division Muradnagar, UPPTCL, shall be Engineer of the contract.

11. VERIFICATION OF BILLS: -

After the work has been satisfactorily complete at the end of each month Contractor will submit bill to concerned JE/AE for recording in MB and Verification in first week of every month or earlier. Any delay beyond that shall have to be justified by JE&AE in the covering letter. There should not be any substantial gap between the date of verification of bills in MB and its submission in the office of EE.

12. DISPUTE: -

In case of any dispute in respect of interpretation of any provision in the contract of any nature in respect of the work, the decision of the Superintending Engineer, Electy. Trans. Circle, UPPTCL, Ghaziabad shall be final & binding upon both the parties.

13. JURISDICTION OF COURT: -

The contract shall be governed by the Law of Government of India for the time in force in District Ghaziabad in the state of U.P. and shall be under the jurisdiction of Hon'ble High Court, Allahabad.

14. PENALTY: -

The Contractor shall have to execute the above work within stipulated time allowed, failing which a penalty @ ½% per week on remaining work subject to maximum of 10% of amount of the work shall be levied and recovered from the contractor's bills.

15. FINANCIAL CONDITIONS: -

A-PRICE: - To be quoted on rate schedule enclosed.

B-DAMAGE OF EQUIPMENT: - The contractor shall ensure to follow all instruction issued by concerned AS/JE. In case damage of any equipment, if it is found due to negligence of contractor's employee/labour, same shall be recovered from contractor's bill.

16. STATUTORY DUTIES AND TAXES: -

A) LOCAL TAXES AND LEVIES: - All such taxes if levied shall be born by the contractor & deemed to be included in rates quoted.

B) INCOME TAX: - The contractor shall be liable and responsible for payment of such taxes if attracted under the provision of law.

C) GST: - GST as applicable as per provision of the laws shall be paid extra by the department.

17. EARNEST MONEY & SECURITY DEPOSITE: -

a) The contractor shall furnish security @1% of total value of the contract on start of work otherwise shall be deducted from 1st running bill. The amount of earnest money will be converted into security deposit.

b) The security money shall be released after 6 months from the date of successful completion of work.

c) The security money shall be forfeited either in whole or in part at the absolute discretion of the engineer, if the contractor fails or neglect to observed or perform any his obligation under the contract.

18. COMPLETION PERIOD: -

The material shall be delivered within 30 days from the date of this order.

19. TERMS OF PAYMENT: -

a) 90% payment on monthly basis shall be made within one week of submission of bills and 100% payment may be released on submission of CDR/FDR of 10% amount of monthly bill.

b) Balance 10% payment or FDR/CDR of 10% amount shall be with held as performance guarantee and shall be released after 6 months period from the date of completion of work after necessary certification by JE/AE that the work has been completed satisfactorily as per specification and nothing is outstanding against the contractor against this agreement or any other agreement of Dn.

20. MODE OF PAYMENT: -

a) All payment shall be made through account payee cheques only drawn on the banker of the concerned division.

b) Proper receipt of the cheques must be given in the office before the cheque delivered to contractor.

c) The cheque shall only be delivered to the person having executed the agreement or any authorized representative of the firm with his signature duly attested.

21. WITHHOLDING OF PAYMENT: -

The payment can be with held on account of following at the discretion of engineer.

- a) Violation of any contractual obligation on part of the contractor.
- b) Failure by the contractor to make due payment of material or labour employed by him.
- c) In sufficient progress of work. When the ground for with holding the payments are removed, payment shall be made without any delay.

22. NOTICE TO CONTRACTOR: -

Any notice may be given to contractor, if the Corporation thinks fit by the Registered post on the address given below:

23 . Registration of ESI, EPF, WC Policy, Labour License and Electrical Safety Registration:-

- a) The Applicant must be registered in ESI & EPF respectively including Labour department Registration in UP Govt.
- (b) *The Applicant must be registered as Class "A" contractor in Electrical Safety Department of UP or any other State Govt. or Central Govt. (which shall be verified) and shall get extended during the tenure of Agreement.
- (c) The Bidder must submit Character Certificate issued by District Magistrate (DM) valid on the date of Bid Submission.

Copies of Certificates in this respect shall be submitted along with Tender documents.
