Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

**1. Generic**

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the

revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

## 2. **Buyer Added Bid Specific ATC**

2. Duration: Three (03) breakdown visits per year.

4. Mandatory- 48 hours response time and 01 week for resolving the issue.

### **(I) Scope of Work**

1. The Annual Maintenance Contract (AMC) is for a period of Three years. Faulty parts or consumables will be purchased as and when on the basis of the requirement.
2. The AMC provider must have OEM authorization, the requisite expertise and experience for servicing the equipment of same or similar make. To prove this, the AMC provider must submit detailed list of national and international customers and at least three testimonials from reputed multinational lab or government labs.
3. Company should endorse a service engineer having at least 02 years of experience in servicing this instrument.
4. The service engineer must carry company ID Card.
5. Once a breakdown call/service call is raised it should be attended within 48 hours. Number of breakdowns call per year is three (03).
6. In addition to breakdown calls, the AMC provider must provide preventive maintenance including calibration of AAS per year.

### **(II). Special Terms and Conditions.**

- (a) The general terms & conditions defined in the Terms & Conditions for GeM products and services are applicable for this service as well as extent applicable.
  - (b) The annual maintenance includes 01 preventive maintenance per year as per bid and on any unscheduled call for corrective and maintenance service.
  - (c) Immediately on award of the service order the service provider would give a report regarding taking over of the equipment for maintenance purpose. It shall be the responsibility of the service provider to make the equipment work satisfactorily throughout the contract period.
  - (d) In case of delay in attending to problems, breakdown of system due to improper handling by service provider personnel etc. suitable penalties for violation of service level agreement shall be levied as indicated in the penalty clauses.
  - (e) The AMC shall be carried out during working day in office hours. III. Penalty: 1. If the service provider by the agency will not be satisfied to the authority or user of the instrument, then the office reserves the right to terminate the contract i.e., payable only up to the period, till which the agency has rendered satisfactory services. The decision of Head of this Office regard shall be final and binding on the agency.
2. In case of non-compliance with the contract, we reserve the right to cancel/rescind/revoke the contract and impose suitable penalty in proportion to the damages.
  3. The minimum response time is 48 h and the maximum response time for repairing the system shall not be more than 01 week and penalty for failure of the agency to respond within the stipulated time will be ₹ 1000/- per system per day.
  4. Liquidated Damages (LD): after having been notified by the buyer through email/fax regarding the defec

ts/service requirement during AMC period, the seller has to allocate and send service engineer to visit the site during breakdown and complete the required service/rectification, covered under the AMC. There will be 98% uptime warranty during AMC period on 24(hrs.) X 7(days a week) X 365(days per year) basis, with penalty, to extend the period by double the downtime period. If the seller fails to send the service engineers to visit the site and complete the service/rectification, within the defined time limit, a penalty of 0.5% of the total value (excluding taxes) of the agreed payment cycle, as the case may be, shall be charged as penalty for each week of delay from the seller. The buyer shall have the right to choose any of the two options [extending of AMC period by doubling the downtime period or a penalty of 0.5% of the total value (excluding taxes) of the agreed payment cycle for each week of delay from the seller] for invoking the penalty. The buyer shall have the right to deduct the penalty amount from the bill claimed from the seller for payment or recover all such penalty amount from the performance security bond. Cumulative penalty will be 10% of the total contract value.

## **Arbitration:**

“All disputes or differences arising out of or in connection with the Contract shall be settled by bilateral discussions. Any dispute, disagreement or question arising out of or relating to the Contract or relating to product or performance, which cannot be settled amicably, shall be resolved by arbitration in accordance with the following applicable provision:

a) For Central and State PSEs: In the event of any dispute or difference relating to the interpretation and application of the provisions of commercial contract(s), such disputes or difference shall be taken up by either party for resolution through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD) as per provisions of Department of Public Enterprises OM No. 05/0003/2019-FTS-10937 dated 14 Dec 2022 as amended.

b) For Defence PSUs: The case of arbitration shall be referred to the Secretary Defence(R&D) for the appointment of arbitrator(s) and proceedings.

c) For other Firms: Any dispute, disagreement or question arising out of or relating to the Contract or relating to product or performance, which cannot be settled amicably, shall be resolved by arbitration in accordance with either of the following provisions:

“The case of arbitration may be referred to arbitrator/arbitrators appointed as per section 11 of the Indian Arbitration and Conciliation Act, 1996 as amended and the proceedings shall be conducted in accordance with procedure of Indian Arbitration and Conciliation Act, 1996 as amended.”

Or

“The case of arbitration may be referred to International Centre for Alternative Dispute Resolution (ICADR) for the appointment of arbitrator and proceedings shall be conducted in accordance with procedure of Indian Arbitration and Conciliation Act, 1996 as amended.”

Or

“The case of arbitration may be conducted in accordance with the rules of Arbitration of the International Chamber of Commerce by one or more arbitrators appointed in accordance with the said rules in India. However, the arbitration proceedings shall be conducted in India under Indian Arbitration and Conciliation Act, 1996 as amended.

### अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller.
