Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. **Generic**

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

2. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

3. **Service & Support**

4. **Service & Support**

SCOPE OF WORK AND SPECIAL CONDITIONS OF CONTRACT

1. The package of the Mini Truck is Up to 2500KM per month and the requirement is for 24x7 Service. Therefore, the truck with driver must be available for "round the clock (24x7)" and "as and when required" at the headquarter, with keys and all the necessary documents of truck. This is to facilitate quick movement at the required location.
2. The period of contract will be 03 years (36 months) from the date of acceptance. However, Railway reserves the full right to terminate the contract at any time without assigning any reason thereof before the completion of contract period. Service Provider shall not be entitled for any kind of compensation in case of such termination.
3. Disciplined, knowledgeable and experienced driver with utmost sincerity & courtesy must be assigned for duty.
4. Proper contact details of driver should be notified to the concerned consignee. The driver needs to be available at the place of the truck within a short time (should not exceed 20 minutes) after getting a call from consignee. Any delay in arrival of driver/vehicle, due to any reason, will attract a deduction/penalty as per GeM SLA.
5. If the Service Provider fails to depute/engage driver as per Para (4) due to any reason, then consignee can hire/engage railway or any other driver to perform regular duties, and for this purpose the truck provided by Service Provider against this contract can be used by her/him without taking any permission from Service Provider or his staff/representative. However penalty for non-availability of driver will be applicable as per GeM SLA.
6. Any cost towards driver's salary, allowances, fuel, repairs, maintenance, breakdown, petty expenses etc. will be borne by the Service Provider only.
7. The truck provided by Service Provider against this contract must have sufficient fuel all the time full (not less than 40% of tank capacity) during the currency of the contract period and it will be the responsibility of driver to top up the fuel at his own cost whenever it comes below the indicated level. The above condition of fuel is equally applicable in case of hybrid fuel model (if available) so that in emergency condition truck can reach at destination without facing fuel shortage problem en-route.
8. It will be the responsibility of Service Provider to provide sufficient Imprest to the driver to meet with the petty expenses towards fuel, parking, repair, toll charges etc., if any. Delay towards movement of truck due to lack of Imprest with driver will be treated as a fault and is liable for deductions towards delay as per GeM SLA.
9. The truck provided by Service Provider must be neat & clean and must be in well maintained condition. In case of any breakdown/schedule maintenance, suitable replacement must be provided by Service Provider. In case the replacement is not provided, the same shall be liable for penalty as per GeM SLA.
10. In case of any emergency, the truck should move immediately to the place/station in any direction whenever/whenever required as per the instructions of consignee.
11. On duty driver shall be provided with identity card, duly issued by the Service Provider & duly authorized by railway representative.
12. Service Provider shall maintain proper log book for the truck and same will be signed by Authorized representative on regular basis.
13. The truck shall be utilized for the transportation of Railway materials, construction materials, machinery & equipment etc. as per the requirement of consignee.
14. In case of any accident, Railway will not be responsible for any loss to vehicle or person. Railway will not

ot bear any type of compensation arising thereof due to accidents of any type.

15. Extra per km charges, if any, shall be settled as per GeM SLA.

16. Extra hour charges and Outstation Charges are NOT applicable.

17. Penalty/deductions, if any, will be governed as per GeM SLA.

18. The settlement of bills shall be as per Package (Up to 2500 Kms/Month) only, along with deductions (if any). Extra KM beyond the package (if any), in any month, may be logged and kept in record properly. The average of monthly recorded KMs shall be done for the purpose of calculating the extra KMs beyond the package. Payment, if any, towards extra per km charges shall be settled as per GeM SLA at the time of final invoice of the contract.

19. All the Terms & Conditions mentioned in Service Level Agreement (SLA) of GeM will be applicable

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
