1. 1. This category is BIS Scheme - 1 compliant. Catalogs must have valid and active CM/L license number owned by the applicant themselves. In case of non-compliance, appropriate action may be taken against OEM / Brand / Seller as per the GeM IM Policy.

The gas shall be supplied compressed in Cylinder. The design of the Cylinder, pressure of gas in Cylinder, packing, marking, painting, labelling, storage and transport of Cylinder shall be in accordance with the Gas Cylinder Rules , with such modifications as may be ordered from time to time by the CIE, PESO, DPIIT, MoC&I, Gol.

The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and
- All operative provisions of the erstwhile Labour Laws until their complete substitution.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
