If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 6. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. General Duties & Responsibilities The Unarmed Security Guards deployed by the Service Provider shall:

1.1 Maintain round-the-clock security and vigilance of the office premises, including entry/exit points, corridors, parking areas and surrounding premises. 1.2 Regulate and monitor the movement of visitors, staff, vehicles and materials entering or exiting the premises. 1.3 Verify identity cards/passes of visitors and maintain visitor entry registers as prescribed. 1.4 Prevent unauthorized access, trespassing, theft, pilferage or damage to government property. 1.5 Remain alert and attentive during duty hours and promptly report any suspicious activity to the Reporting Officer. 2. Access Control & Monitoring 2.1 Ensure proper checking of bags, parcels and vehicles, wherever required, without causing inconvenience to authorized personnel. 2.2 Assist in crowd control and orderly movement during peak hours or official events. 2.3 Ensure strict compliance with security instructions issued by the Buyer from time to time. 3. Emergency & Incident Handling 3.1 Respond immediately to emergencies such as fire, medical emergencies, law & order situations, or natural calamities. 3.2 Assist in evacuation procedures and coordinate with local authorities (Police/Fire/Medical) as and when required. 3.3 Record and report all incidents, accidents or security breaches in the prescribed register. 4. Conduct, Discipline & Turnout 4.1 Security Guards shall be well-behaved, courteous, disciplined and alert at all times. 4.2 Guards shall wear prescribed uniform with proper identity

badge during duty hours. 4.3 Consumption of alcohol, tobacco or any intoxicating substance during duty hours is strictly prohibited. 4.4 The Service Provider shall replace any guard found unsuitable, indisciplined or inefficient, immediately on direction of the Buyer. 5. Qualification & Deployment Conditions 5.1 Guards shall meet the qualifications, age limit and experience as specified in the GeM Bid document. 5.2 All deployed personnel shall be physically fit and medically sound. 5.3 The Service Provider shall ensure timely deployment and shall arrange substitute manpower in case of leave/absence, without any additional cost to the Buyer. 6. Statutory & Legal Compliance 6.1 The Service Provider shall comply with all applicable labour laws, rules and regulations including EPF, ESI, Minimum Wages, Bonus, Gratuity and other statutory obligations. 6.2 Wages to the guards shall not be less than the rates notified by the Administration, UT Chandigarh (DC Rates), as applicable. 6.3 Any liability arising out of non-compliance of statutory provisions shall be solely borne by the Service Provider. 7. Supervision & Reporting 7.1 The guards shall work under the overall supervision of the Reporting Officer nominated by the Buyer. 7.2 Attendance shall be marked daily in the prescribed format/biometric system, wherever applicable. 7.3 Monthly bills shall be submitted by the Service Provider along with attendance records and statutory compliance proof. 8. Confidentiality & Code of Conduct 8.1 Guards shall maintain strict confidentiality regarding official matters and records. 8.2 No information related to office functioning shall be disclosed to any unauthorized person. 9. Termination / Penalty 9.1 The Buyer reserves the right to terminate the contract or impose penalties as per GeM terms in case of unsatisfactory performance, breach of contract or non-compliance of conditions. 9.2 The Service Provider shall be bound by all GeM General Terms & Conditions and Service Level Agreement (SLA).

3. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

4. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
