Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up

to 25 percent of bid quantity at the time of placement of contract. 13. **Warranty**

Warranty period of the supplied products shall be 3 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. 14. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 7 days time limit. 11. Point to point compliance to be provided.

GENERAL TERMS AND CONDITIONS

- 1) SECURITY DEPOSIT Cum PERFORMANCE BANK GUARANTEE: The Supplier has to submit SD cum PBG for 3% of PO value (Including GST). Immediately after receipt of PO, valid upto 60 days beyond warranty period The SD cum PBG is to be executed through Demand Draft/ Fixed Deposit Receipts or Bank Guarantee (In the Name ACCOUNTS OFFICER, LEOS) issued by a Nationalized Bank/Scheduled Bank/an International Reputed Bank approved by Reserve Bank of India, Govt. of India as per our specimen. The SD cum PBG shall be executed on a Non-Judicial Stamp paper of appropriate value not less than Rs. 300/- In the case the supplier fails to furnish the SD cum PBG within 20 days or any extension thereof, the Purchase Order shall be cancelled or terminated and appropriate penal action shall be initiated. Any breach of the Terms & Conditions of the PO including Delivery Period, SD cum PBG shall be forfeited and PO shall be terminated and cancelled at the supplier's risk, cost and liability. The SD cum PBG will not carry any interest and shall be returned after expiry of warranty period with claim period of sixty days. Supplier shall execute the Bank Guarantee as issued by Bank through Structured Financial Messaging Systems (SFMS), only after which paper Bank Guarantee shall become operative.
- 2) As per Tender Terms the Liquidated Damages: if the vendor fails to deliver the items on or before the agreed date, purchase will recover as Liquidated Damages @0.5% per week or part thereof subject to a maximum of 10% of the order value.
- 3) Liquidated Damage: The time and date stipulated in the contract for completion of the work shall be deemed to be the essence of the contract. DEPARTMENT OF INDUSTRY AND INTERNAL TRADE (DPIIT) NEW DELHI
- 6) General Terms & conditions for Bidders: For this procurement, bids from Class I & class II Local Suppliers are admissible. hence provisions contained in Public Procurement (Preference to Make in India), Order 2017 issued by Department for Promotion of Industry and Internal Trade (DIPP), Ministry of Commerce & Industries vide letter No. P 45021/2/2017 PP (BE II) dated 04.06.2020 and subsequent amendment & directives shall be followed. Accordingly, offer will be evaluated & processed in conformance with above referred GOI order (Specially mentioned below).
