7.A.1. EMD CRITERIA:

The bidder should submit the EMD (Ref: EMD details of Bid Document @Page No.2/11) or valid MSE certificate for relevant Category as per Page No. 2/11 of GeM tender document or any other valid document to claim EMD exemption.

7.A.2. WORK EXPERIENCE CRITERIA:-

The bidder should have satisfactorily completed in three previous financial years and the current financial year up to the date of opening of the tender, one single similar service contract** for a minimum of 35% of the advertised value of the bid.

*Completed service contract includes on-going service contract subject to payment of bills amounting to at least 35 % of the advertised value of the bid.

Similar service contract means **“Execution of work in diet preparation, diet service and overall management of diet in central/State Government/P.S.U establishments”

Work experience certificate from private individual shall not be accepted. Certificate from public sector company/Private company/Trusts having annual turnover of Rs. 500 crore and above subject to the same being issued from their Head office by a person of the company duly enclosing his authorization by the management for issuing such credentials.

Note-1:- The bidder shall submit details of work executed by them in the in the prescribed format (**ANNEXURE-A**) along with bid for the service contracts to be considered for qualification of work experience criteria clearly indicating the nature/scope of contract, actual completion cost and actual date of completion for such contract.

7.A.3. FINANCIAL STANDING CRITERIA:-

The Bidders will be qualified in this criteria only if they have minimum financial capabilities as below:

Financial Annual Turn-over :-

The bidder should have an aggregate financial turnover not less than 1.5 times the advertised Bid value during the last three previous financial years and in the current financial year up to the date of opening of the tender. The audited balance sheet reflecting financial turnover certified by chartered account and with her stamp, signature and membership number shall be considered.

The bidder shall submit details of satisfying financial standing by them in the prescribed format Annexure-B along with bid for the service contracts to be considered for qualification of financial standing criteria. The Certificate shall also contain the UDIN of the issuing C.A.

7.A.4. ANNEXURE-D: Bidder must upload annexure - D attached in Buyer added bid specific documents on (To be executed in presence of Public notary on non-judicial stamp paper of the value of Rs.100/-. The stamp has to be in the name of the tenderer), failing which offer shall be summarily rejected.

7.A.5. ANNEXURE-E: Bidder must submit information/undertaking w.r.t. employment/partnership of retired Railway employee as detailed in Annexure- E.

7.A.6. PBG (PERFORMANCE BANK GUARANTEE):- The successful contractor to whom contract is awarded shall be required to submit PBG at 5% of contract value within 15 days of award of contract. Delay in submission beyond 30 days will attract penal charges on late submission at the rate of 15% of the PBG amount. In case contractor fails to submit PBG within contract start date or 30 days from the date of award of contract whichever is earlier, otherwise the contract shall be terminated duly forfeiting EMD and other dues, if any payable against the contract.

If the contractor has commenced work, but the payment to contractor shall commence only upon submission of PBG and its verification from issuing bank.

7(B). OTHER INSTRUCTIONS TO BIDDERS:-

7.B.1. Only those documents which were uploaded by bidders/sellers along with their original bid shall be considered for technical evaluation. Any documents submitted after the date of closing shall not be considered for evaluation. Further any document uploaded during representation stages shall also not be considered for evaluation.

7.B.2 Document to be submitted along with bid: Bidder has to submit documents related to following eligibility Criteria is mandatorily along with bid.

(a) Scanned proof of the EMD submitted in the GeM tender, or the document for EMD exemption.

(b) Experience Certificate as per tender condition as per ANNEXURE-A.

(c) Financial Annual Turnover Criteria document as per tender condition as per ANNEXURE-B.

(d) Compliance of Annexure- D & E.

(e) Undertaking regarding FSSAI certificate to be obtained and submitted to the Consignee before commencement of the work, if the contract is awarded.

Note:- 1. Any mandatory Certificate/document without incomplete information is likely to be rejected.

Note:-2. The completion Certificate and any other documents are likely to be cross-verified with the issuing Authority/Organization. If any facts or information is found to false/incorrect, the offer will be rejected and/or the Contract will be terminated at the risk and cost of the bidder/contractor.

Note:-3. Non-submission of any documents required in bid document will lead to rejection of offer during technical evaluation, and no correspondence shall be entertained in this regard.

7.B.3. In case any discrepancy between the GeM System generated Terms and Conditions and the Buyer Added ATC & Buyer Uploaded Documents, then the Terms and Conditions in " Buyer added ATC & Buyer Uploaded Documents" shall be final and binding.

7.B.4. The Successful bidder shall be required to obtain a FSSAI Certificate at the time of commencement of the work without which the contract can not commence. After award of contract the FSSAI Certificate valid for the currency of contract is to be produced by the firm directly to the Consignee. The bidder should submit an undertaking in this regard along with their bid.

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
