2. 4. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. 3-It Will Be Mandatory For The Firm To Upload The Character Certificate, GST Certificate, Turnover Certificate , Net Worth, PAN Card, Bidder should present Rs.100- affidavit of non-blacklisting in India before the bid end date and should not be more than 90 days old, Bidder must submit Past Project Experience , Make In India Certificate, Financial Standing Undertaking.

4-If the uploaded document is Not Readable than the Seller will be Disqualified.

5-It will be mandatory for the Bidder to upload the audited balance sheet.

6-It will be mandatory to upload the proof of GST deposit amount of form GST 3B GSTR-1.

7-An Authorization Letter from OEM Must Be Submitted On Letter Head of OEM Addressing Bid Number And In Favor Of Tender Inviting Authority.

8-Bidder Will Not Be Considered In Absence Of The Any Certificate.
