If the bidder wants to avail themselves of the Purchase preference, the bidder must be the

manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 4. The bidder/OEM should have experience of successfully executing the supply and installation of office furniture items in each of the last 5 years up to the present date in any State/Central Govt organization. The bidder should provide technically clear completion certificates in the appropriate format, mentioning details of tender value, awarded work value, time of completion, and performance results.

5. The experience certificate will be considered in technical evaluation.

10. Bidder/OEM must be a member of BIFMA. All quality-related certifications asked in the bid must be submitted with the technical bid.

11. Quoted product should have **GreenGuard Gold, BIFMA Level 2, IAQ Gold, GreenPro** and should be verifiable online.

12. The OEM of the products must have a Zero Wastage to landfill certificate issued by Confederation of Indian Industry (CII) for its manufacturing plant(s). This Certificate should be Valid at the time of participation in the bid.
13. The bidder should furnish an affidavit on Non-Judicial Stamp Paper of Rs. 100/- that the bidder is not blacklisted/de-listed or debarred for any product by any Central Government/State Government/Semi Government/PSU/Banks/Universities/Educational Institute/Autonomous body etc., Pan India, due to any reason.
14. EMD is mandatory for all bidders – resellers as well as OEMs. Non-submission of EMD will disqualify the bidder.
15. The Bidder should submit item-wise specification compliance as given in the bid in the form of a Data Sheet matrix; the Bidder must upload Specifications Offered by their respective OEM.
16. The Bidder/OEM shall have in-house manufacturing for steel furniture/processed woods/Powder Coating/Optimizer manufacturing as required for the products/items of work in this tender. The bidder will submit sufficient documentary proof of the manufacturing facilities by submitting Factory License, EPF Registration, ESIC Registration, Trade Mark Certificate of the Brand Name, GST Registration, etc. In case of the Bidder being an Authorized vendor, OEM Documents must be attached along with an authority letter from a competent person of the OEM for submission of documents.
17. The Bidder/OEM should not have incurred loss in any 2 consecutive years during the last 5 financial years ending on 31st March 2025.
