**3. Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

**1. Generic**

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

The Scope of Work shall broadly include but not be limited to the following activities:

1. The Consultant should be a Notified Private Exploration Agency (NPEA) as notified by NMET / State Government / Government of India.
2. The Bidder should have prior experience in reconnaissance surveys (G4 level) or higher stages of mineral exploration such as G3 / G2 / G1 level exploration, preferably in Base Metals, Copper and Associated Minerals.
3. The Bidder should have successfully completed at least one (01) similar project in the above commodities during the last three (03) years.
4. The Bidder shall have qualified and experienced professionals on its roll including but not limited to:
  - Professional Geologists
  - Geophysicists (preferably having around 10 years' experience)
  - Arc GIS / Remote Sensing Experts

#### **Minimum qualification and experience of professionals should preferably include:**

- M.Sc. / M.Tech in Geology / Geophysics or equivalent qualification from recognized University / Institute.
- Relevant field experience in mineral exploration for planning and execution of G3 and G2 level exploration activities through integration of geology, geophysics, remote sensing, geochemistry and allied studies.

#### **5. Financial Criteria:**

- The average annual financial turnover during the last three (03) financial years ending 31st March 2025 shall not be less than 30% of the estimated contract value.
- The Bidder should have positive net worth.
- The Bidder should not have any history of financial default, insolvency or bankruptcy.

#### **6. Past Performance & Credibility:**

- The Bidder shall submit work orders / completion certificates issued by previous clients.
- The Bidder should not have any history of major contract termination due to poor performance.
- Experience of working with Government Departments / PSUs such as GSI, MECL, State DMG etc. shall be considered as an added advantage.

7. The Bidder should not be blacklisted / banned / debarred by any Central Government Department / State Government Department / PSU / Government Agency as on the date of submission of bid.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority.
