1. Special Terms and Conditions for Truck Mounted Jetting Machine

- The category: "Truck Mounted Jetting Machine" is to cater to the requirement of procurement of jetting machines mounted on truck body. This category is bid only category and Direct Purchase is not enabled.
- Additional details like capacity of auxillary engine, additional attachments, warranty requirements and customizations may be specified by the buyer in the bid.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract.
