1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small

Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

### 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Eligibility Criteria: Only bidders who qualify on following criteria are eligible to participate in the tender:
  - a) This is a case of procurement of proprietary item of spares from M/s Rockwell Automation .The bidder shall be M/s Rockwell Automation Private Limited or its authorised channel partner for automation and drives. The party must also be a System Integrator.  
The bidder,if authorised dealer,shall furnish the above certificates and bid specific authorisation from theOEM/OES for participation in this tender.  
OEM shall be severally and jointly responsible along with the bidder for performance of the contract.  
Note:
    - a) SAIL reserves the right to verify any supporting document(s) submitted by a participating tenderer/bidder from its source(document issuing authority)
    - b) In the interest of expeditious completion of verification, a participating tenderer/bidder shall provide a list of each supporting document on its letterhead as per "Annexure-S"along with the contact details (postal address, e mail address, landline/mobile number)of the issuing authority of each supporting document of verification
    - c) Non-verification of any supporting document or information at the sole discretion of SAIL, does not absolve the tenderer/bidder of its absolute responsibility to provide only genuine document(s)in support of eligibility conditions.
    - d) In case a supporting document or information is found to be fake/forged/tampered/non-genuine at any stage during tendering process and even after placement of purchase order/work order, the tenderer/bidder is liable for punitive actions as per extant guidelines of SAIL
2. **Terms and conditions:**
  - a) Executing Authority shall be GM (EED/SMS & CCS-FM) or his authorised representative.Vendor shall communicate the expected system downtime in the upgradation activity to the Executing Authority and shall commence the upgradation activities only after getting confirmation from them.
  - b) Payment terms:
    - (i) 60% amount will be released after delivery of materials and rest 40% will be released after successful commissioning of the drive.
    - (ii) Commissioning certificate will be issued by the Executing authority of the concerned department.
  - c)Standard warranty/warranty clause is applicable i.e. the vendor shall guarantee the entire system including hardware, software and accessories for a period of 18 months from the date of delivery or 12 months from the date of acceptance of the system after installation, integration, and commissioning whichever is earlier.
  - d) Performance Bank Guarantee: Within 15 (Fifteen) days from the date of Placement of Purchase Order, the successful supplier should Performance Bank Guarantee in the form of a bank guarantee for an amount equivalent to 5 % of contract value. The BG should be valid for minimum 15 months from the date of commissioning. Successful Bidder can submit the SD in the form of ePBG/ online payment through RTGS / Internet banking also. On-line payment shall be in Beneficiary name of Alloy Steels Plant. Bank Details shall be shared after placement of contract.

The price differential in case of higher cost to SAIL,if any, shall have to be borne by the defaulting supplier. Moreover the defaulting supplier shall have no claim over the quantity, which they failed to supply.

5. Banning of Business Dealings: On arising any situation or occurrence of any event as mentioned in Clause 6 of the Guidelines on Banning of Business Dealings available on SAIL Tender website(www.sailtenders.com) , the tenderer/bidder or supplier under the tendering process or contract with SAIL,as the case may be, shall be liable for action under and in accordance with the aforementioned Guidelines.The “Guidelines on Banning of Business Dealings” shall form part of the Tender/Contract.

## 7. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

## 8. **Generic**

Without prejudice to Buyer’s right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the

stipulated Delivery Period or such inability otherwise becomes apparent.

iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

iv) The Seller becomes bankrupt or goes into liquidation.

v) The Seller makes a general assignment for the benefit of creditors.

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
