1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

- The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

4. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

6. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

7. Buyer Added Bid Specific ATC

1.2 The contractor shall provide mobile communication system in vehicle for smooth communication and shall be maintained including the running expenditure till completion of the work at his own.

1.3 The contractor shall maintain a record in separate logbook in prescribed format (Format-B) for hired vehicle for daily meter reading, which shall be jointly signed by the Rly. supervising the vehicle and the driver of the vehicle. It will be duty of the driver of the vehicles to ensure that the logbook is properly filled in and in overwriting/cutting should be got authenticated by the supervisor using the vehicle.

1.4 The vehicle being provided by the tenderer should have proper documents such as Registration Certificate of the vehicle. The same shall be uploaded on GeM during quoting of rates.

1.5 The vehicle should have proper and ongoing insurance; the insurance should be in force for the duration of the contract.

1.6 The contractor should display a printed board in front of the vehicle with bold and words "ON GOVERNMENT DUTY" (Western Railway) while working against this contract.

1.7 The payment of the vehicle shall be made as per the actual kilometers travelled by the vehicle. The payment shall be made after deduction of applicable deductions if any.

1.8 The vehicle shall be immediately provided after the GeM contract is issued to the contractor, any delay over shall automatically lead to Penalty / termination of the tender and forfeiture of amount submitted as PG/EMD/SD as per extant guidelines of SLA of GeM.

2. Buyer Added Bid Specific Terms and Conditions · The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under. · In case of any emergency and site inspections the seller has to provide the services for 24x7 Hours and on weekly off days also as per instructions of Engineer in charge or consignee. · Vehicle is required for Day and Night as when required then separate drivers for Day and Night to be provided. · Only commercial vehicle is allowed in this contract; Private passing vehicle will not be allowed. After completion of day i.e. in the evening or holidays, vehicle must be kept in the custody of consignee at the consignee's office. · Valid Vehicle Insurance and RC documents of Vehicles which are going to be given May be submitted while bidding. The Hiring of vehicle i.e SUV has been approved and Sanctioned up to dt.31.01. 2028 by the Competent Authority. The SUV are required for the use of (Dy. CSTE/C/BRC, DSTE/C/BRC. ADSTE/C/BRC.)

4. Affidavit for Submitted Documents:

The bidder must upload a notarized affidavit on stamp paper stating that all documents submitted in the bid are true, genuine and authentic.

In case any document is found false, fabricated or misleading at any stage, the buyer reserves the right to reject the bid and take necessary action as per GeM rules and applicable laws.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.

8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider.
