#### **Experience :**

- A. The bidders must have experience of performing SCADA work (commissioning) as the prime contractor for at least one 132 KV or above Transmission substation during past 3 year in UPPTCL. A satisfactory performance certificate issued by the user shall have to be submitted in this regard. (Attach the copy of agreement & work completion certificate from concerned Executive Engineer)
- B. Only those bidder who have authorization from OEM (SIEMENS, ALSTOM, HITACHI/ABB, ZIV, GE (T&D), ARTECH,) for SCADA services during the past 2 year shall be eligible to participate in the tender.

Bids from Bidders not having relevant experience shall be liable to be rejected. The Bidder shall have to submit copy(s) of Relevant agreement/order(s) directly placed on them for the work (as specified above). ### **2.0 Financial Qualification**

**2.1** The Minimum Average Annual Turnover\* (MAAT) will be taken as Average of the Best Three Financial Years Turnover out of the Last Five financial year preceding to the year of NIT is published. In case the Applicant is in existence for less than five financial years the minimum average annual turnover shall be average of the turnover of the completed no. of financial years. The Applicant who is in existence for less than one complete financial year shall not be qualified.

**The MAAT shall not be less than Estimated cost .** The project related turnover of the tendering company on standalone basis only (excluding its associate companies /Holding Company) shall be considered.

**2.2** The Applicant shall have **Liquid Assets** (Cash at Bank & Fixed Deposit) and Un-Utilised credit facility (both Fund & Non Fund based) available from bank(s) duly certified by the Bank(s) at the end of Month preceding to the previous Month of Tender opening, **shall not be less than 15% of Estimated cost**

**2.3 Net worth of Applicant** as per the audited financial results **shall be positive** on the last day of the preceding financial year. Net Worth means the sum total of the paid-up share capital and free reserves (excluding reserves created out of the revaluation of assets, write back of depreciation provisions and amalgamation & Capital Reserve) net of P&LA/C (Dr. balance) and miscellaneous expenses to the extent not adjusted or written off.

**2.5** The Owner reserves the right to reject the proposal of the Applicant, if:  
(a) The Applicant made misleading or false representation in the form of statements and attachments submitted in proof of the qualification requirements.  
(b) Has a record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion.

**2.6 Registration of ESI, EPF, WC Policy, Labour License and Electrical :**

**afety Registration:-**

- a) The Applicant must be registered in ESI & EPF respectively including Labour department Registration in UP Govt.
- ( b ) \***The Applicant must be registered as Class A contractor in Electrical Safety Department of UP or any other State Govt. or Central Govt. (which shall be verified) and shall get extended** during the tenure of Agreement.
- (c) The Bidder must submit Character Certificate issued by District Magistrate (DM) valid on the date of Bid Submission.

**2.7 Applicants Credibility Criteria:**

- (i) The Applicant who stands currently debarred by UPPTCL / Any DISCOM of P / Govt. of UP or black listed by any Distribution/ Transmission/ Generation Utility/Govt. Department in India as on the schedule date of opening of tender shall not be eligible to participate in this tender.
- (ii) The Applicants should not have any pending litigation with UPPTCL with regard to any O&M Work/Project or related activity.
