Scope of Work: Short-Term Strategy for Sale of Copper Concentrate

1. Objective

The objective of this engagement is to develop a short-term, actionable strategy for the sale of copper concentrate that optimizes revenue, manages commercial risk, and aligns with prevailing market conditions. The scope covers sales process design, pricing mechanisms, market assessment etc and benchmarking the same against industry best practices.

2. Scope of Services

2.1 Sales Process Review and Optimization

- Ø Assess current sales (spot vs. term contracts, traders vs. smelters, geographic mix).
- Ø Identify gaps and risk areas in the current process.
- Ø Recommend an optimized sales process, including:
 - o Buyer engagement and qualification approach
 - o Contract tenure and volume allocation strategy
 - o Governance, approval, and decision-making framework

Deliverable: Sales process assessment and recommended optimized sales framework.

2.2 Pricing Mechanism Analysis

- Ø Review current pricing mechanisms used for copper concentrate sales, including:
 - o Treatment and refining charges (TC/RCs)
 - o Payable metals in Copper Concentrate, Unit deductions applicable, penalties, Quotational Period, etc, considering high metal prices.
- Ø Analyse different pricing structures (fixed annual vs. Bench mark linked TC/RCs, floor/ceiling mechanisms, provisional pricing),
- Ø Recommend a pricing mechanism suitable for short-term sales & long-term sales that balances revenue maximization and risk management.

Deliverable: Pricing mechanism options with pros/cons and recommended approach.

2.3 Market Assessment

- Ø Conduct a short-term market assessment for copper concentrate, including:
 - o Global mine production and regional supply-demand dynamics
 - o Smelter capacity, utilization rates, and concentrate tightness
 - o Current and near-term TC/RC trends
 - o Key consuming regions and buyer behaviour
 - o Identify priority target markets and buyer segments for the short term.
 - o Highlight key commercial risks (market volatility, logistics constraints, geopolitical or regulatory factors).

Deliverable: Market assessment summary with implications for sales strategy for domestic/export

2.4 Benchmarking

Benchmark the company's current sales and pricing practices of domestic/international player with Comparable copper concentrate producers/traders for best international practice in

- o Industry norms for TC/RCs, payables, penalties, and contract terms
- o Identify best practices and competitive positioning.
- o Pricing structure & deductions limits with similar Concentrate composition for Copper, Iron, Sulphur & insoluble.
- o Quantify potential value gaps where feasible.

Deliverable: Benchmarking analysis and gap assessment.

3.0. Timeline to Submit Final Report: Final Report to be submitted in 21 days from Contract date.

4.0. Payment Terms: Payment shall be made in 30 days, after due acceptance of the bills raised by the party

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.
