In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers

offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. **Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

4. **Generic**

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

5. **Generic**

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

6. **Generic**

End User Certificate: Wherever Bidders are insisting for End User Certificate from the Buyer, same shall be provided in Buyer's standard format only.

7. **Generic**

Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for 3 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. 16. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

19. Warranty

Warranty period of the supplied products shall be 5 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during

the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

20. Warranty

Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.

21. Warranty

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 5 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

Buyer Added text-based ATC clauses:

1. The bidder shall submit a copy of the audited financial statements for the last three (3) financial years (F Y), including the annual turnover, duly authenticated by a Chartered Accountant (CA). The minimum annual turnover requirement, if specified, should be met.
2. The bidder is required to submit a certificate confirming acceptance of all technical specifications mentioned in the bid document. Any deviation from the specified technical requirements must be clearly identified and submitted for evaluation and consideration.
3. The bidder must provide a valid GST registration certificate, issued by the relevant authorities, along with the bid submission. The GST registration must be active and compliant with Indian tax regulations.
4. In case the bidder qualifies as a Micro, Small, or Medium Enterprise (MSME), a valid MSME registration certificate must be submitted with the bid. The certificate should be issued by the Ministry of Micro, Small, and Medium Enterprises (MSME), Government of India.
5. The bidder shall submit certificates evidencing their experience in the supply and delivery of items/parts for the last three (3) years. The certificates should be issued by the end-users or respective government/defense entities.
6. The bidder is required to provide a valid "Make in India" certificate for the offered products, confirming that the items are manufactured in India as per the guidelines set forth by the Government of India.
7. The bidder must submit an OEM certificate or an authorization letter from the OEM (if applicable) confirming that the offered items/parts are genuine, original, and manufactured by the OEM.
8. Attendance at the pre-bid meeting is mandatory for all interested bidders. Failure to attend the pre-bid meeting will result in disqualification of the bidder from the bidding process. The pre-bid meeting is crucial for discussing technical re

quirements and quality assurance standards.

9. The bidder must submit physical samples of the offered parts/items before the technical bid opening. The samples will be evaluated for quality, specifications, and compliance with the requirements. Bids will be disqualified if the required samples are not submitted within the stipulated time.

10. The bidder must provide a warranty certificate for a period of two (2) years from the date of successful installation/commissioning of the items/parts. The warranty certificate must be signed and stamped by the authorized signatory of the bidder and included in the bid submission.

11. The items/parts offered by the bidder must conform to the technical and quality specifications as outlined in the bid document. Any deviation from these specifications will result in disqualification from the bidding process.

12. The items required under this tender must meet military or defense specifications, as applicable. The bidder must provide supporting documentation to demonstrate compliance with such specifications. Non-compliance will lead to automatic disqualification.

13. Bidders who fail to submit any of the required documents, including but not limited to the annual turnover certificate, GST registration, MSME certificate, OEM certificate, warranty certificate, or any other mandatory documents, will be disqualified from the procurement process.

14. Bidders whose offered products do not meet the technical specifications or fail to provide the required samples for evaluation will be disqualified from further consideration.

15. Any bidder who does not attend the mandatory pre-bid meeting will be disqualified as per the guidelines of the procurement process.

16. The technical bid will be evaluated based on compliance with the specifications, submission of required documents, and the quality of submitted samples. Any bid found non-compliant with the requirements will be disqualified.

17. The successful bidder shall adhere strictly to the delivery schedule as stipulated in the contract. Any delay in delivery beyond the agreed timeline may lead to penalties, cancellation of the contract, and blacklisting of the vendor.

18. All goods supplied under the contract will be subject to inspection by the authorized inspection team. The bidder shall be responsible for ensuring that the goods conform to the technical specifications, quality standards, and contractual terms.

19. The bidder shall provide adequate after-sales support, including technical assistance, repair services, and the availability of spare parts throughout the warranty period.

21. Land border GFR 144 undertaking signed by authorized person of firm/ company.

22. Declaration of product manufacture life certificate signed by authorized person of firm/ company.

23. Declaration certificate (No Bankruptcy, etc) signed by authorized person of firm/ company.

24. BIS Certification This certification is mandatory under the Electronics and Information Technology Goods (Requirements for Compulsory Registration) Order, 2012. It ensures the safety and quality of printer and other electronic products

25. ISO Certification.

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
