6. Any item taken out from ADE premises for repair, the vendor should submit comprehensive insurance in the name of Director, ADE Bangalore.

c) For other Firms: Any dispute, disagreement or question arising out of or relating to the Contract or relating to product or performance, which cannot be settled amicably, shall be resolved by arbitration in accordance with the following provision

The case of arbitration may be referred to arbitrator/arbitrators appointed as per section 11 of the Indian Arbitration and Conciliation Act, 1996 as amended and the proceedings shall be conducted in accordance with the procedure of Indian Arbitration and Conciliation Act, 1996 as amended.
