1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 3. Purchase preference to Micro and Small Enterprises (MSEs) from the State of Bid Inviting Authority : Purchase preference will be given to MSEs as Micro and Small Enterprises from the State of Bid inviting Authority. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 20% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 50 % of total quantity as defined/ decided in relevant policy.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

C. The OEM should have a Registered Office in Gujarat. DOCUMENTARY EVIDENCE TO BE SUBMITTED. Latest copy of any of the following: Property Tax bill / Electricity Bill / Telephone Bill / GST Registration / Lease Agreement at the time of submission of bid

3.Past experience:

- a. **A Estimated Bid Value:** The OEM must have successfully completed at least one single order of **50 % of the Estimated Bid Value for same or similar items such as Preschool Education kit OR supply of slates during the preceding 5 financial years (i.e.2020-21, 2021-22, 2022-23, 2023-24 and 2024-25) to any Govt Organization / PSU.**
- b. **B.Quantity:** It is required that OEM **must have supplied 27000 PSE kits having games/ puzzles/ drawing book in the form of a kit and not individual items in Single Order in any of preceding 5 financial years i.e.2020-21, 2021-22, 2022-23, 2023-24 and 2024-25) to any Govt Organization / PSU.** It has to be certified by CA.
- c. C. With regards to Point 3a and 3b, copies of contracts / work orders / documentary evidence of successful execution / completion in support of Past Experience of Similar Services have to be attached for evaluation

4. The bidder must bid for all Items & whole quantity. Partial bidding will be rejected.

5. Certificates :

A. As per Toys Quality Control Order 2020 issued by Department for Promotion of Industry and Internal Trade, the manufacturer should have BIS license. Copy of license shall be submitted along with the technical bid.

B. To assess production NSIC/CSPO certificate will be used and for assessing supply of GeM Work orders/GeM generated Contract/Work completion certificates will be utilised.

C. The bidder is required to upload, along with the bid, all relevant certificates such as BIS license, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

D. Products supplied shall be nontoxic and harmless to health. In the case of toxic materials, Material Safety Data Sheet may be furnished along with the material.

6.Bidder financial standing:

A. OEM should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

7. The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

8 Bidder must not be blacklisted or debarred by any State/Central Govt./PSU authority at any time. 8. Bidder should not have defaulted in supply of products to any State/Central Govt./PSU entity. Bidder must submit a self-declaration to this effect along with the bid.

9. Bidder shall be disqualified in technical stage if any inquiry is underway against the bidder or any FIR is filed against the bidder or any case is pending against the bidder on charges of corruption, fraud, impropriety etc. Bidder must submit a self-declaration that no such inquiry/FIR /case is underway against it.

10. The successful bidder to provide 2(Two) sample kit at no cost for the buyer's approval. The supply will commence only after the competent authority approves the samples. The Sample has to be submitted within 10 days of the Work order/Contract order. If samples are not submitted in given time the penalty will be deducted as per GeM GTC. **Additionally, at the time of submitting samples, quality report from a Government Laboratory is to be enclosed conforming with the specifications.**

11. The slates have to be delivered at the district level. The product is under 4 years of Warranty . Therefore, bidders to quote price accordingly.

12. One sample kit shall be collected from each consignee location. These sample kits shall be tested at any Govt. lab for conformance with the specifications. Cost of testing shall be borne by the selected bidder. Seller is advised to include the testing charges while submitting financial bid. Payment shall be made only after positive testing report is received.

13. Replacement of item supplied: When the supply is ongoing or after the supply gets completed if any item is found defective or not confirming to the specifications, supplier shall be promptly intimated of the same and item has to be replaced at no extra cost within 10 days at received consignee location. It may be noted that this duration of REPLACEMENT is for a period before the warranty period commences as during Warranty other Terms and Conditions will operate.

14. The buyer reserves the right to cancel the bid or contract during any stage of bid process without assigning any reason at any time.

15. Bidder must have turnover of Rs.13.62 Cr (Thirteen Crore Sixty Two lakh) on an average in the last 3 years i.e. (2022-23,2023-24 and 2024-25) As per Gujarat Procurement policy 2024.

16. Bidder has to submit Self-Declaration Certificate for Local Content and also submit Local content certificate (MII)

18. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

19. The seller is required to print logo as per buyer's requirement.

20. **Penalty Clause-** In addition to the described conditions, the OEM will have to abide by the following Penalty clauses.

a. Delay in Delivery:

If the bidder fails to deliver to consignees within 30 working days of the issue of production order, then a sum equivalent to one percent (1 %) of the total contract value of respective consignee for the concerned di

stricts shall be deducted from the payment for each calendar week of delay or part thereof. The amount of penalty for delay in delivery shall be subject to a maximum limit of 10% of the total contract value. Delay in excess of 10 weeks will be sufficient to cause for termination of the contract. In that case the Performance Bank Guarantee of the bidder will be forfeited.

b. Variation from Specification Criteria:

Variations found in the product delivered other than the “Allowed Values” mentioned in the tender specification shall not be tolerated. If any of the delivered products are not fulfilling the tender specifications, then the seller shall be liable to replace the entire quantity of that consignee within 10 calendar days without any condition. If the supplier fails to replace the product within 10 days then a penalty @ 5 % (Five Percent) shall be recoverable from him.

C. Warranty:

Bidder has to complete the required Replacement / Rectification within 7 days time limit. If the bidder fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the bidder.

D. Cumulative Penalty:

Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security(PBG).Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to reimburse the cost of such service / rectification to the Buyer. Further, If there are instances which raise the cumulative penalty more than 10% of the contract value, in that case it would be sufficient cause for termination of the contract and the Performance Bank Guarantee of the bidder will be forfeited.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The

Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
