1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.
2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.
3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or

similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

7. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

3. Forms of EMD and PBG

4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. If the bidder is an Original Equipment Manufacturer (OEM OEM-authorized distributor, should have its registered office in Guwahati.

2. Sub-letting of the contract is not allowed.

3. Bidders must provide a complete product catalogue containing specifications of all implants.

4. Each implant must include manufacturer/ Make name, model , catalogue no, brand name , if any, batch number, date of manufacture, date of expiry, distributor's name, MRP, GST% etc for the price they have quoted etc.

5. Bidder must provide an undertaking that the implant supplied has been constructed from the material whose metallurgical test report has been submitted as per guidelines.
6. The hospital reserves the right to conduct random checks on the metallurgical status of supplied implants.
7. The hospital authority reserves the right to test any supplied items. Failed items will be returned, and action will be initiated as per Government of India rules.
8. Firms should provide quality/standard certificates ensuring high standards of items, where applicable.
9. Bidders must provide all necessary instrument sets required for surgery. Failure to do so may result in forfeiture of the e-PBG (electronic Performance Bank Guarantee).
10. Companies must supply full sets of instrumentation required for all cases, along with a full range of implants.
11. Proper guide wires, drill bits, exchange tubes, and other essential instruments/ equipment must be provided at the bidder's cost.
12. When required, companies must provide power drills, reamers, and other essential equipment at their own cost.
13. For revision implants, companies should provide instruments for removal of well-fixed implants and cements.
14. A good working standard drill/saw system/separator system should be provided for cases at the company's cost, if required by the department.
15. All items should be supplied on a case-to-case basis as demanded.
16. Vendors are responsible for refilling used items for the next case on a priority basis.
17. The bid for orthopedic items is a running rate contract, and items must be supplied within 24 hours of receiving an email / phone calls after getting supply order.
18. Actual number / size of implants used will be decided on the surgery table. Unused number / sizes will be returned to the bidder after surgery.
19. Excess instruments not required for surgery will be returned to the bidder after the procedure.

22. If items are not used or required, the supplier shall accept them for replacement /return, and the cost shall be adjusted from the due amount.
23. For items with a shelf life of two years or less: Items should not be older than 1/4 of their shelf life at the time of delivery.
24. For items with a shelf life of more than two years: Items should not be older than 1/6 of their shelf life at the time of delivery.
25. All imported items must have a minimum of 50% shelf life remaining at the time of delivery. For imported items, necessary certificates must be submitted.
26. The hospital authority reserves the right to test any supplied items. Failed items will be returned, and action will be initiated as per Government of India rules.
27. Bidders must provide demonstrations within 7 days if required by the hospital.
28. The company should provide technical assistance and training for hospital staff as needed.
29. A knowledgeable company representative / scrub person should be available in the operation theatre to assist surgeons with instrumentation and implants.
30. The surgical technique for each implant should be provided (both hard and soft copy) along with templ

ates.

31. All bidders must comply with all statutory guidelines of the Government of India/ CVC / Audit / GFR
32. The decision of the Dean / Medical Superintendent, ESIC Medical College & Hospital, will be final regarding demonstrations and other matters.
33. Companies should be able to provide more than one set of instruments per day if required.
34. Company representatives / one trained person with working knowledge of the implant should be provided for all the cases should coordinate with OT staff for supply and use of items in the operation theatre at their own cost.
35. Instrument sets must be provided free of cost one day prior to surgery against a challan and collected back after surgery completion.
36. No claims for instrument damage during use or due to normal wear and tear will be admissible.
37. All ortho implants which are not manufactured in India, imported license, trade license, CDSCO certificate & other relevant documents to be provided.
38. If item is proprietary, proprietary article certificate to be provided with authorization of the manufacturer.
39. Joints implants should be USFDA (USFDA approved) approved.
40. Shaver machine and Arthroscope should be provided free of cost.
41. In any category or item not quoted in the bid, it should be provided at the time of OT with no extra cost.
42. Correct utilization certificate as per patient's record should be submitted monthly & should match with that of OT utilization certificate & both soft copy (through email) & hard copy to be submitted in office before uploading of GeM invoices, bidder should contact store dept for correction of any invoices if any.

The bidder must submit the supporting proprietary article certificate and other documents.
47. Tender rates will be valid for one year from the date of signing the contract agreement and may be extended for another one year or until the consumption of the implants whichever is earlier.
48. e-PBG should be valid normally for 14 months & may be extended accordingly if the bid needs to be extended.
