Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

If the buyer has mentioned MSE purchase preference in ATC then service provider is required to upload necessary documents for MSE purchase preference for verification by the buyer during evaluation.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Conditions specific to LTE.

1. This Limited tender enquiry is being floated through GEM custom bid for procurement of item "PRIMER GASKET PART NO.6409794 LF-2013999910 ". Only bidders who are established for subject item PRIMER GASKET PART NO.6409794 LF-2013999910 and same item PRIMER GASKET F1301-036530-D LF-2013436143 (established with MIL group of factories/erstwhile OFB) and registered with any factory/Unit under MIL/erstwhile OFB/MIL vendor registration portal for tendered item will be considered. For any vendor, which is not registered, it will be essential to submit online VRRF (through link -vendor.munitionsindia.in) before bid end date, else their offer will not be considered. If above website doesn't work, then firms have to fill offline VRRF form attached along with bid document and submit requisite fee before bid end date. **Established suppliers also have to get themselves registered at OFK for the tendered item if their registration expires.** Established vendor have to submit valid registration certificate along with bid documents.
2. **PACKING DETAILS FOR RUBBER COMPONENTS** - Packing of rubber components should be in heat sealed opaque polyethylene bag with film thickness not less than 0.075 mm. The opaque polyethylene should be "free from copper naphthenates, creosole preservatives and plasticized polyvinyl chloride (PVC)".
3. Offer of those bidders who are not established or registered source of the item under procurement at OFK shall be rejected/ignored.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
