Scope of Work: Hiring of Commercial Vehicles on Monthly/Daily Basis

1. Purpose of Hiring

The vehicle is required for the official use of the Superintending Archaeologist and Archaeological Officers for:

- Inspection of Centrally/State Protected Monuments.
- Supervision of ongoing Archaeological Excavations and Site Surveys.
- Transportation of departmental staff and sensitive equipment (like cameras, measuring tools, and site maps).
- Official visits to Gandhinagar (Secretariat) and various District Collector offices.

2. Vehicle Specifications

- **Model Type:** SUV (Bolero/ Bolero neo/ Ertiga)
- **Condition:** The vehicle must be in excellent mechanical condition, preferably not older than 5 years or having run less than 50,000 km.
- **Registration:** Must be registered as a **Commercial Vehicle** (Yellow Number Plate) with a valid permit to travel across all districts of Gujarat.
- **Cleanliness:** The vehicle must be cleaned daily; seat covers must be white/beige and washed weekly.

3. Driver Requirements

- **License:** Driver must possess a valid commercial driving license.
- **Conduct:** Must be well-behaved, and maintain strict confidentiality regarding departmental discussions.
- **Experience:** Should be familiar with the geography of Gujarat, especially routes leading to historical sites (which are often off the main highways).
- **Mobile Connectivity:** Driver must carry a functional mobile phone available 24/7.

3. Operating Terms (The "Duty" Cycle)

- **Standard Kilometers:** Usually 3,000 km per month.
- **Working Hours:** Normally 8 hours per day, and must be available for early morning site visits or late-night returns during field tours.
- **Night Halts:** During site inspections, if a night halt is required, the department will provide a fixed "Night Halt Allowance" to the driver.

4. Maintenance and Fuel

- **Comprehensive Cost:** The quoted rate shall be inclusive of fuel (Diesel/CNG), lubricants, repairs, insurance, and taxes.
- **Toll and Parking:** Toll taxes and parking charges incurred during official duties will be reimbursed by the department upon submission of original receipts.
- **Breakdown:** In case of a breakdown, the agency must provide a replacement vehicle within 2 hours.

5. Logbook Management

- The driver must maintain a **Daily Logbook** indicating:
 1. Opening and Closing Odometer readings.
 2. Total Kilometers run.
 3. Locations visited.
- The logbook must be verified and signed daily by the using Officer. This logbook is the primary document for bill processing.

6. Statutory Compliances

- The agency must comply with all RTO regulations, including valid PVC (Pollution), Insurance, and Fitness certificates.
- **GST Compliance:** The agency must provide a valid GST invoice. (As discussed earlier, RCM may apply if the agency is unregistered, but usually, the department prefers GST-registered vendors).

Special Clause for Archaeology Department:

"The vehicle may be required to travel on unpaved (kucha) roads or rugged terrain to reach remote archaeological mounds or excavation sites. The vendor must ensure the vehicle (preferably an SUV/Bolero) is capable of handling such terrain without additional charges."

Category item bunched with it.

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
