If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. ##### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the

additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### ADDITIONAL TERMS AND CONDITIONS

1. The bidder shall mandatorily have sufficient experience, expertise and provided similar type of plant and machinery to any Govt. organization during the last 3 years.
2. The plant & machinery to be supplied shall comply with the norms laid down by PPCB/CPCB/SBM-U.
3. The rates quoted by the bidder shall include the cost of Cement Concrete platform, sheds (as per requirement) and other civil works required for complete installation and electrical works required for commissioning of the machinery. However the electricity connectivity will be provided by the organization.
4. The final installation of plant shall be at Cantonment Composting Ground, located near abandoned MES Lagoon Pan Area, Jalandhar Cantt.

11. The machinery will be suitably compatible with loading / unloading of waste materials.
