1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25 % percentage of total quantity.The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023. [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

ADDITIONAL TERMS AND CONDITIONS

1. Manufacturing Capacity

The Bidder Should be a strictly Original Equipment Manufacturer of required item (OEM) or Authorized Dealer of OEM. Documentary proof to be submitted: valid OEM authorization certificate on OEM's letter head clearly mentioning bid number duly signed and stamped.

2. Past Performance:

The bidder should have experience of successfully executing at least three supply contracts past three years ending on 31 March 2025 in any state or central Govt school/college/institution. The bidder should provide technically clear completion certificate in appropriate format mentioning details of value of tender, value of work awarded, time of completion and result of performance etc.

3. Safety and Quality standards:

The bidder shall ensure that sports items should conform to the relevant BIS (IS) specifications, wherever applicable.

Testing: Test reports from BIS recognized Laboratory or NABL Accredited Laboratory.

4. Sample Evaluation:

Sample evaluation will be stage-2 of technical bid and financial bid of only those bidders to be opened whose samples are declared qualified by technical evaluation committee. The technically qualified bidders are requested to submit the samples of all the items mentioned in bid documents within **five (05)** days from the date of qualifying technical evaluation of the bid, failing which the tender/bid shall be rejected outrightly.

5. Financial Eligibility:

The Annual Turnover of the bidder (Reseller / Non-OEM) during the last three financial years shall be not less than 50% of **Total** bid value, supported by audited financial statements/CA-certified statements of accounts for **the relevant years**. In **case** the bidder is not OEM, the OEM of the offered product shall have a Minimum Annual Turnover of **38,20,00,000** - (Thirty Eight Lakhs Twenty Thousand only) during the last three financial years, supported by audited financial statements or CA-certified statements. Supporting documents must be uploaded under the "Turnover Documents" section of the GeM bid. Bidder shall submit **CA-Certified financial statement**, including supporting schedules, conforming to the requirements of the tender.

turnover and profitability, Income Tax Returns (ITR) for **the last** three fiscal years and TR-3B filing for last three months must accompany the Bid.

6. **Earnest Money Deposit (EMD) and EMD exemption:**

An EMD amounting to INR **28650/-** (Twenty Eight Thousand Six Hundred Fifty only) **must** be pledged in favor of **the Zonal Education Officer** Tullamulla, and submitted along with **the bid** proposal. Failure to comply will lead to disqualification of the bidder.

The bidder seeking EMD exemption must submit the valid supporting document for the relevant **category** as per GeM terms and condition with the bid. Under MSE category only manufacturers of goods and **service** providers for services are eligible for exemption from EMD.

7. **OEM Product Data Sheet Requirement:**

The bidder shall submit the official Product Data Sheet (PDS) issued by the Original Equipment Manufacturer (OEM) for each product offered in the bid. The Product Data Sheet must include, **at a minimum**, the product name, model number, technical specifications, key features, compliance certifications, operating conditions, and warranty information.

The Product Data Sheet shall serve as evidence that the product being offered is genuine, OEM- approved, and meets the technical requirements specified in the bid. Bidders failing to provide the OEM Product Data Sheet may be considered non-compliant, and their bid may be rejected.

All Product Data Sheets **must** be uploaded in the "Technical Documents" section of the GeM bid along with the quotation. Buyers shall verify the Data Sheet with the **off** specifications. Any mismatch will **render** the bid liable for rejection.

8. **Declaration and Undertakings:**

The Bidder and OEM must submit an Undertaking affirming that neither the firm has been debarred, blacklisted and suspended by any Central/State Government Department, University, or PSU.

9. **Delivery Condition:**

The Supply of items should be made within the time period of 10 days from the date of issuance of contract at Zonal HQ. In case of delayed in supply, liquidated damage to 1% per week, **subject** to maximum of 10% of order value will be imposed.

10. **Payment terms:**

Payment shall **be** made after successful delivery of all **the** items at Zonal HQ. The Committee shall undertake **the** verification of procured materials and inspect each delivered item **to** confirm its conformity with **the** agreed-upon specifications, quality, quantity, and any **other** pertinent parameters outlined **in the** Bid terms and conditions **before** the payment.

11. The bidders should also abide by the rules laid down in the GFR-2017 and Procurement of Goods and Services strictly.

12. **The** quantity of the items in the bid is subject to availability of funds which can decrease or increase.

13. That bidder should strictly adhere to the rule viz a viz communication with the department **i.e** that **they** shall not make any telephonic Messages / calls and Personal approach to any govt. official of this office. However, in case of any query bidder must approach via GeM platform only.

14. At any stage during the bidding process or after the issuance of the formal supply order, if any document submitted by the participating firm is found to be forged, invalid, perjured, misleading, or otherwise non-genuine, this office reserves the absolute right to cancel/terminate the bid, reject the offer, or annul the supply order without any liability whatsoever. The participating bidder shall mandatorily submit a **bid-specific undertaking** affirming the authenticity, genuineness, and validity of all documents submitted and confirming unconditional compliance with this condition.

15. Compliance Certificate:

All **the bidders must submit bid** compliance certificate regarding bid document and **ATCs and technical compliance for each item on bidder's letter head.**

16. The bidder should comply with the specifications for all the components of the supply items mentioned in specification document and it must be ensured that the materials furnished are of good quality and of reputed brand.

17. The contractor is to be entirely responsible for the execution of the contract. All respects in accordance with the terms and conditions as specified in the Bid document.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
