If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned

Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. ### 1. **Generic**

**OPTION CLAUSE:** The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. **Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

### 4. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 5. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

### 6. **Forms of EMD and PBG**

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

### 7. **Buyer Added Bid Specific ATC**

Buyer Added ATC

1. During the technical evaluation of bids, buyer can ask for all the original documents/ Registration Certificates of vehicles /Licenses of Drivers to scrutinize the bids. The bidders have to produce the requisite documents within 02 working days, failing which the bid will be disqualified and no further request will be entertained.

2. The model mentioned in the bid document, i.e., Mahindra XUV EL Pro, is indicative and not restrictive. Bidders must quote the said model or any equivalent category electric SUV, with a financial quote for only on

e model.

3. The Service Provider will provide the requisite number of Electric Vehicles as and when required in the Department and has the capacity to fulfil the demands of vehicles on urgent need also.

4. The fleet of owned vehicles of the bidder should be 100% (18 Electric Vehicles) to ensure no sub-letting/ sub-contracting of the contract in their fleet. Copies of the RCs must be uploaded.

5. The bidders must upload RCs of Electric Vehicles registered in the name of firm/ proprietor in their bids. The Department may at its discretion verify the RCs through RTO Authorities concerned and also asked for original RCs for verification.

6. After award of contract by the GeM, only those electric vehicles shall be deployed whose RCs were uploaded during participation in bid or any other vehicle purchased by the bidder after award of contract. Such vehicle should also be registered in the name of firm/ proprietor.

7. After award of contract by the Department on GeM Portal, the successful bidder must begin the service from the start date of contract. No request for providing additional time will be entertained.

8. Bidder must not upload redundant/ irrelevant and illegible documents. Such documents may lead to rejection of the bid.

9. All the necessary documents/ undertakings shall be bid specific. Generic documents/ undertaking will be rejected summarily without assigning any reason.

10. At any stage after the commencement of the contract, if the services of the service provider are found unsatisfactory and derogatory to the terms & conditions of the contract, the Department reserves the right to terminate the contract by giving one month's notice. No compensation shall be payable, and the Department will recommend the bidder for debarment/blacklisting on GeM, if warranted.

11. After award of contract, no relationship of employees and employer will be created between the drivers so deployed by Service Provider and this Department. It will be the sole responsibility of the service provider to pay salary and other perks to its drivers on time and no complaints by any driver in this regard will be entertained by the Department and such incidents will be viewed seriously.

12. The duration of contract period may be extended upto 1 year at the same rate and T&C after completion of initial contract duration subject to satisfactory performance of the service provider and mutual consent.

13. The bidder has to make arrangements for inspection of all 18 Electric Vehicles at Supplier's site, in order to verify the make, model (2025), and condition of the electric vehicles.

14. The RCs of all the vehicles and Police Verifications of all the Drivers to be attached with this Department must be completed by the bidder prior to deployment. An undertaking has to be furnished by the bidder to this effect

15. The bidder shall have experienced, proficient, well-dressed, and soft-spoken drivers on their payroll who also have whereabouts of all the Govt offices located in Delhi/ NCR.

16. In case of dispute of any kind, the firm shall abide by the decision of the Competent Authority in the Department of Personnel & Training. In case the dispute is required to be referred to Arbitration, it will be referred to the sole arbitrator under Arbitration and Conciliation Act, 1996. The place of settlement of dispute shall be Delhi. In case the settlement of dispute is sought through the Courts, it will be in the jurisdiction of the Courts in Delhi.

17. The office and garage of the service provider where all cars are parked after end of duty shall be within 12 km radius of Kartavya Bhawan 03, New Delhi. Documentary evidence such as GST registration, tourism licence, shop act registration must be submitted.

18. The Charging stations for the Electric Vehicles of the service provider shall be within a 12 km radius for electric vehicle deployed at Kartavya Bhawan 3 building & Lok Nayak Bhawan and Old JNU campus.

19. The charging cost EVs shall be included in the rates quoted by the bidders.

20. The bidder shall possess valid transport license issued by Tourism Department, Govt. of NCT of Delhi.

21. Bidder must submit undertaking for accepting all the Buyer Added ATC on their letterhead.

22. The bidder must not have been blacklisted or had any contract terminated due to unsatisfactory performance by any Government Department in the last three years. An undertaking to this effect must be submitted.

23. Bidders require to sign a Bid Securing declaration as per Annexure-I accepting that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids document, they will be suspended for the period of time specified in the request for bids document from being eligible to submit Bids for contracts with the entity that invited the Bids.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
