### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Bidders may kindly note that the Other Group for the Group Tender is published as GEM/2026/B/7170386. Bidders are requested to go through the mentioned GeM Bid before submission of their bids. The Methodology for the same is as provided below:

1) Bidders may quote rates in individual groups namely, Group-A, B, C, D etc in which they intent to participate.

2) Bidders shall be required to quote as the same bidding entity (either as a sole bidder or as a consortium or as an unincorporated JV etc.as allowed in the tender) in all the groups, wherever they are participating. The bidder participating as a multiple bidding entity in different groups of the same tender shall be rejected. This clause shall be included in the tender conditions.

3) Price bids shall be opened for techno-commercially qualified bidders for individual groups. Qualified bidders, quoting lowest price in each of the groups after reverse auction (if applicable) will be declared as L-1, L-2, L-3 and so on, in increasing order of their quoted price. Even if the bidder has quoted in multiple groups, where he is individually qualifying, his bids shall be opened for all such groups, whether or not he is qualifying for multiple groups in combination.

4) Price bid evaluation shall be done on overall landed cost basis. After RA is concluded, a cost-matrix will be prepared based along with Price Comparative Statement (PCS) on techno-commercially eligibility of vendors i.e. identification of bidders as L-1, L-2 etc. in the following manner:

a) If a bidder is L-1 in only one group, it will be considered for being awarded the said group.

b) If it is observed that a bidder is L-1 for more than one group for which the bidder is also techno-commercially eligible when taken together, those groups will be considered for being awarded to the bidder. For example, if a bidder is L-1 in two groups and is techno-commercially qualified for these two groups taken together, these two groups will be considered for being awarded to the bidder.

c) If a bidder is L-1 in multiple groups but is not meeting the prequalification criteria for such combination of groups taken together, or, cannot be awarded all such groups due to restrictions as per tender conditions ; L-2 (or even L-3) shall become deemed L-1 for such groups. The bidders to be considered for award of such groups will be decided based on least cost combination to IOCL from within such multiple groups.

d) In consonance with above, while placing orders, for offer(s) on the least cost option from multiple groups, the work of any group may be awarded to L-1/ deemed L-1 bidder in the group.

Efforts can be made to match the price of deemed L-1 bidder with L-1 bidder in that group. Least cost combination for the bidders shall be formed after opening of price bids. Negotiation if applicable shall only be done with L-1/ deemed L-1 bidder.

Further May Kindly Take Note of the Following Point that: -

i) IOCL reserves the right to place orders on the least cost option offer(s) under all circumstances.
