1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. In case the date of constitution incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

Applicant should have successfully completed the construction, installation and commissioning work of min. **02 Nos.**(AIS/GIS) Bays **132 KV or above voltage class** in last **05 years** for any Transmission Licensee or Generation plant and as on the originally scheduled date of tender opening i.e.09.03.2026

2.0 Financial Qualification

- 2.1** The Minimum Average Annual Turnover* (MAAT) will be taken as Average of the Best Three Financial Years Turnover out of the Last Five financial year preceding to the year of NIT is published. In case the Applicant is in existence for less than five financial years the minimum average annual turnover shall be average of the turnover of the completed no. of financial years. The Applicant who is in existence for less than one complete financial year shall not be qualified.

The MAAT shall not be less than 23 Lakh. The project related turnover of the tendering company on standalone basis only (excluding its Associate companies /Holding Company) shall be considered.

- 2.2** The Applicant shall have **Liquid Assets** (Cash at Bank & Fixed Deposit) and Un-Utilised credit facility (both Fund & Non Fund based) available from bank(s) duly certified by the Bank(s) at the end of Month preceding to the previous Month of Tender opening, **shall not be less than 15% of Estimated cost.**

- 2.3** **Net worth of Applicant** as per the audited financial results **shall be positive** on the last day of the preceding financial year. Net Worth means the sum total of the paid-up share capital and free reserves (excluding reserves created out of the revaluation of assets, write back of depreciation provision

and amalgamation & Capital Reserve) net of P&LA/C (Dr. balance) and miscellaneous expenses to the extent not adjusted or written off.

- 2.5 The Owner reserves the right to reject the proposal of the Applicant, if:
- The Applicant made misleading or false representation in the form of statements and attachments submitted in proof of the qualification requirement.
 - Has a record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion.

2.6 **Registration of ESI, EPF, WC Policy, Labour License and Electrical Safety Registration:-**

- The Applicant must be registered in ESI & EPF respectively including Labour department Registration in UP Govt.
- The Applicant must be registered as Class A contractor in Electrical Safety Department of UP or any other State Govt. or Central Govt. which shall be verified) and shall get extended** during the tenure of Agreement.
- The Bidder must submit Character Certificate issued by District Magistrate (DM) valid on the date of Bid Submission.

Copies of Certificates in this respect shall be submitted along with Tender documents.

- The Applicant should also have W.C. Policy or give affidavit to take the same before Start of the respective Work allotted to the Firm as per terms of the Contract awarded.

- 2.7 All the hardware material must be type tested as per relevant ISS from NABL Accredited / govt. laboratory during last 5 years (from the bid opening date). Joint venture shall not be accepted and the bidder must have the desired experience/ reports on their own.

3.0 **Experience :**

Only such bonafide experienced and reliable firms need to tender who can produce satisfactory evidence that they have necessary resource and organization to undertake such work of similar nature to the satisfaction of Engineer of contract, failing which, the undersigned reserves the right to reject tender bid.

Bids from Bidders not having relevant experience shall be liable to be rejected. The Bidder shall have to submit copy(s) of Relevant agreement/order(s) directly placed on them for the work (as specified above). Compilation and Performance Certificate

4.0 Applicants Credibility Criteria:
