2. Certifications of the Product including OEM ISO, BEE/Energy Star, ROHs, UL, FCC, TCO 9 for Monitor, EPEAT, ISO, Microsoft Windows Server software & Specific Data Sheet for the Server.

3. OEM should have same make of Keyboard, Mouse, Monitor, and CPU. OEM LOGO /trade mark should be embossed on them (No sticker will be accepted) for Server.

4. OEM presence in India for minimum 15 years with functional office in the State of Consignee Location & also having annual turnover of Rs. 1000 Crore or above. Documentary evidence for the same to be provided along with the offer.

5. Bidder must submit the offer only in Top 3 companies as per IDC report. Documentary evidence for the same to be provided along with the offer.

6. Compliance & Warranty confirmation certificate should be furnished on the OEM's letterhead with name, address, and mail id of the Signatory to ensure their support for this work.

7. Licensed Factory pre-installed certificate for Microsoft Windows Server software should be furnished on OEM Letter with the bid.
