2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. 3. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Minimum Service charge as per Ministry of Finance, Dept. of Expenditure is 3.85%(including GST). Bidders quoted Service charges less than 3.85%(including GST) will not be considered

(A) General Conditions :

1. Contract is for a period of 12 months.
2. All personnel should have functional knowledge of Hindi, English.
3. Any outsourced personnel can be sent to any site for work within the jurisdiction of SR.DSTE/JAMMU.
4. The work will be in shift basis morning(06-14), Evening(14-22), Night(22-06) .The outsourced personnel should be available to work on all days including Sundays and holidays, and they can be called to the office on short notice in case of an emergent / urgent situation and no extra payment will be given for it. Payment will be done for days on which staff performed duty.
5. Material supplied by Railway for working should be properly utilized without causing any intentional damage.
6. An attendance register shall be maintained in the office and signatures shall be scrutinized by Sr.DSTE/Jammu or any other Railway personnel authorized by him to do so.
- 7.DELETED.
8. All personnel should come in proper uniform and shoes.
9. Identity cards shall be issued by the agency/service provider duly taking design inputs forms as mentioned tender document . All outsourced personnel shall always carry the identity card with neck tags.
10. Agency should submit xerox of Aadhar Card, Voter identity card, Address proof and photograph of the outsourced personnel.
11. Agency should fulfill all statutory requirements with respect to labour law, etc. He will bear all liabilities in terms of workmen compensation act in case of any accident/injuries of the outsourced personnel engaged by him.
13. The outsourced personnel engaged by the agency shall not claim any employment in Indian Railways based on working through this Contract.
14. No advance payment will be made by Railways to the agency.
15. Payment to the agency will be made based on the bills raised in GeM duly verified by the Railways.
16. Payment by the agency to the outsourced personnel shall be made on monthly basis between 1 to 5th of the month. In no case, wages shall be delayed beyond 07th of the month.
17. Bill passing officer will be Sr.DSTE and bill paying officer will be Sr. DFM /JAT
18. In case outsourced personnel is not required, Railways shall give a prior notice as per GCC-2018 (services) rules.
19. In case of a serious misconduct by outsourced personnel, agency shall immediately remove him/her/th

em from service on advice of Sr/DSTE/JAT.

20. If required, interview will be taken to judge the suitability of the personnel to be hired.

21. Any unauthorized absence will attract non-payment of salary as per penalty clause in tender document .

22. On being issued Letter of Acceptance for the work, the agency will submit bio data of all the proposed personnel to be hired within a week's time.

23. The personnel should be physically deployed from the 2nd day on which the Railway gives the approval of personnel to be hired.

(B) SPECIAL CONDITIONS

2) This tender is governed by Gem SLA, GTC of GeM, Scope of work in which special conditions are defined . Situation whenever relevant rules/guidelines/clause s are not available in bid conditions, the relevant clause/paras of the General conditions of contract for services will be applicable. GCC for services 2018 and its amendments (up to tender opening date) are available on the Railway board website 5 / 7

3) Post tender opening no new documents (which are not part of original bid offer uploaded by service provider before opening of GeM bid) will be considered for bid evaluation. (c). The Seller shall, notwithstanding the consent and assignment/sub contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under

5)Successful Bidder must submit the Performance Security in the form of Fixed Deposit Receipt/Performance bank Guarantee [Proforma as per Annexure-I of Buyer uploaded ATC document]. FDR should be made out or pledged in the name of SR.DFM JAMMU(Name of the Service Provider). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the buyer after making endorsement on the back of the FDR duly signed and stamped along with a covering letter.

6)Successful Bidder must upload scanned copy of the FDR document in place of PBG and must ensure delivery of hard copy of Original FDR to the buyer within 15 days of award of bid in GeM.

7) Bill passing officer will be Sr.DSTE/JAMMU and bill paying officer will be Sr.DFM/JAMMU (If there is offline bill payment) or as per GeM process (In case of online bill payment conditions will be according to GCC-2018 (services) rules.

These above conditions and all other remaining conditions will be read along with GCC-2018 (services) rules for compliance

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of

16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
