Item: - Hiring of 05 No. Bolero/ Bolero Camper Eqv. (Diesel) vehicle with 02 Drivers for Official use of Civil, Environment, Estate, Survey/Pool, CISF QRT/SRT, ADIC and NGKAC project, Kusunda Area BCCL for a period of 05 years (1826 days) from the date of issue of contract/commencement of work as per following details.

Engagement of vehicles : 24 Hours

No. of Drivers: 02 (Two) Drivers/Vehicle/Day including staggered rest.

Duration of contract: 05 years (1826 days) from the date of commencement of work.

Average run per Day:

1. 50 Km/Day - Bolero: This may increase or decrease, on actual requirement and the contractor has to abide by it. Reimbursement of only fuel (HSD) will be made under the head of Running Cost on actual running basis.
2. 80 Km/Day - Bolero: This may increase or decrease, on actual requirement and the contractor has to abide by it. Reimbursement of only fuel (HSD) will be made under the head of Running Cost on actual running basis.
3. 100 Km/Day - Bolero Camper: This may increase or decrease, on actual requirement and the contractor has to abide by it. Reimbursement of only fuel (HSD) will be made under the head of Running Cost on actual running basis.
4. 50 Km/Day - Bolero Camper: This may increase or decrease, on actual requirement and the contractor has to abide by it. Reimbursement of only fuel (HSD) will be made under the head of Running Cost on actual running basis.

Fuel Supply: - HSD shall be provided by the Contractor.

Mileage: - 14.3 Km/Ltr for Bolero and 10 Km/Ltr. For Bolero Camper

Equivalent vehicle :- Similar in Price range (price of the base model vehicle will be collected from the local Authorised dealers (s)/nearest Authorised dealer from the office of the Tender Inviting Authority) and other specifications

Age of The Vehicle: - Age of the vehicles should not be more than 05 years as on the end date of submission of the bid. If age of the vehicle gets 05 years old between the end date of submission of bid and before the issue of work order/commencement of work, the contractor has to provide different vehicle having same or higher specification.

Before the expiry of 05 years age of vehicles, the owner of the vehicle has to take advance action for replacement of the vehicle. The vehicle is to be replaced before the date of expiry of 05 years age. The replaced vehicle will be inspected by Area Mgr (E&M) or his authorized representative, as the case may be, for determining its fitness in all respect for its road worthiness to run and subsequently will be certified for deployment. The replaced vehicle should be of same or higher specification.

This substitution (in both cases as above) will be allowed only once during the contract period. The vehicle so initially deployed or provided as a substitute by the contractor will be allowed subject to inspection and satisfaction of the management of BCCL. This inspection will be carried out preferably every six months throughout the contract period & after satisfaction of the company, the vehicle will be allowed to ply further.

In case of failure to comply with the above directive, penal actions as per the relevant clause of GeM's Service Level Agreement & Packages shall be applicable including termination of contract. The age of the vehicles will be counted from the purchase date of brand new vehicles. In case the bidder is unable to provide the original purchase date along with its purchase invoice of brand new vehicle, then age of the vehicle will be calculated from the manufacturing date of the vehicle referring blue book/RC of the vehicle.
