Registration / Empanelment Requirement: Contract shall be awarded to only such sellers , who are registered / empanelled / approved / enlisted with

Prospective bidders (if not already registered), are advised to get themselves registered with the said registration authority before bid opening date. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
