3. Terms and Conditions stipulated in ATC will supersede those in GeM GTC and STC in case of any conflicting provisions.

  - c. Quantity Mentioned "1" in Gem Bid for each item represents Lumpsum-price {i.e. {(Quantity x Unit Rate) + Quoted GST} for individual line item.
6. MSE Benefits are Applicable for this work. MSE bidders seeking exemption for EMD and Purchase Preference shall select appropriate option on GeM portal (separately for each i.e. EMD & purchase preference) and should enclose an attested/self-certified copy of UDYAM registration certificate, failing which they run the risk of their bid being passed over as ineligible for the benefits applicable to MSEs.
7. **The submission of bid by the bidder on GeM portal shall be construed that bidder has read and gave an unconditional acceptance to all the tender conditions including Important Conditions of Tender/Undertaking/ Declarations as stipulated at Attachment-13 (i.e Indicated in Section - VII Forms and Procedures).**
8. **All the bidders are required to furnish PAN & GSTIN of their firm.**
