1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

The subject Procurement is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a class 1 local supplier for subject works is 60%.

Bidders who are Class-2 local suppliers & Non-Local suppliers are not eligible for submission of bids for the subject Procurement. If any bidders who are Class-2 local suppliers & Non-Local suppliers submit their bid, the bids shall be rejected and considered as Non responsive.

QUALIFYING REQUIREMENTS:

A. General

- i. Qualification of bidder will be based on meeting the minimum pass/fail criteria specified below regarding the Bidder's technical experience and financial position as demonstrated by the Bidder's responses in the corresponding Bid Schedules. Technical experience and financial resources of any proposed subcontractor(s) shall not be taken into account in determining the Bidder's compliance with the qualifying criteria. The bid can be submitted by an individual firm meeting the Qualifying Requirement (QR).
- ii. The Employer may assess the capacity and capability of the bidder, to successfully execute the scope of work covered under the package within stipulated completion period. This assessment shall inter-alia include (i) document verification; (ii) bidders work/manufacturing facilities visit; (iii) manufacturing capacity, details of works executed, works in hand, anticipated in future & the balance capacity available for the present scope of work; (iv) details of plant and machinery, manufacturing and testing facilities, manpower and financial resources; (v) details of quality systems in place; (vi) past experience and performance; (vii) customer feedback; (viii) banker's feedback etc.
- iii. POWERGRID reserves the right to waive off minor deviation if they do not materially affect the capability of the bidder to perform the contract.

B. Technical Experience

- (i) The manufacturer(s) whose 145kV or higher voltage class dry type Air Core Reactor is offered, must

to have manufactured, type tested (as per IEC/IS or equivalent standard) and supplied 145kV or higher voltage class dry type Air Core Reactor, which are in satisfactory operation# for at least two (2) years as on the originally scheduled date of bid opening.

- (ii) Alternatively, the manufacturer, who have established manufacturing and testing facilities in India for the offered equipment and not meeting the requirement stipulated in (i) above, can also be considered provided that
- a) 145kV or higher voltage class dry type Air Core Reactor must have been manufactured in the above Indian works & type tested (as per IEC/IS standard) and supplied as on the originally scheduled date of bid opening; and
 - b) provide additional warranty of Two (2) years over & above the warranty period as specified in the bidding documents for the entire quantity of the offered equipment to be supplied under the contract. Further, contractor shall furnish Performance Bank Guarantee for an amount of 10% of the ex-works cost of the equipment(s) for the additional warranty period in addition to the contract performance guarantee to be submitted by the contractor.

In case if bidder is a holding company, the technical experience referred to in clause B above shall be of that holding company i.e., excluding its subsidiary / group companies).

In case bidder is a subsidiary of a holding company, the technical experience referred to in clause B above shall be of that subsidiary company only (i.e., excluding its holding company).

C. Financial Position

2. **Manufacturing Quality Plan:** Bidders meeting qualifying Requirements of the subject package shall submit Manufacturing Quality Plan (MQP) approved by POWERGRID as on scheduled date of bid opening. In case the same got expired on the date of scheduled date of bid opening, the successful bidder shall get it validated without any additional financial implication to POWERGRID and submit before dispatch without affecting the delivery scheduled as per the LOA.
3. **Inspection:** Reactors will be inspected at manufacturers/Suppliers premises by POWERGRID QA&I representative or any other POWERGRID representative nominated by competent authority.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
