Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

The buyer organization is an institution eligible for concessional rates of GST as notified by the Government of India. The services for which bids have been invited fall under classification of GST concession and the conditions for eligibility of concession are met by the institution. A certificate to this effect will be issued by Buyer to the Seller after award of the Contract. Sellers are requested to submit their bids after accounting for the Concessional rate of GST.

4. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

5. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

Tender Terms and Conditions / Relaxations

- The agency must submit the bid keeping the Scope of Work in mind. If any condition of the contract order issued to the bidder is violated, the buyer reserves the right to cancel the contract without prior notice.
- During the last three financial years ending 31 March, the bidder must have a minimum average annual financial turnover or actual production value equal to **at least twice the tender value**. Supporting documents such as certified audited balance sheets for the relevant period or a certificate from a Chartered Accountant/Cost Accountant showing financial turnover or production value must be uploaded with the bid.

- If the bidder has been established/registered for less than three years, this criterion will be applied based on the average turnover or production of the completed financial years after establishment.
- The same rule will also apply to GeM procurement.

Tender Fee and EMD Criteria

A. Eligibility for Exemption:

The following are eligible for exemption:

- a) Micro and Small Enterprises directly participating in the tender process for products/services for which they have Udyam registration and are registered with CSPO or NSIC.
- b) Startups directly participating in the tender process, recognized under the DPIIT Startup India program, and having Udyam registration and CSPO/NSIC registration.
- c) Organizations registered with Gujarat Khadi Gramodyog Board, KVIC, or the Commissioner of Cottage Industries.
- d) Central/State Government boards, corporations, or PSUs for goods manufactured by themselves.
- e) State government-recognized organizations such as:
 - Organizations for blind, deaf, mentally challenged, physically or mentally disabled persons.
 - Women self-help groups recognized by Gujarat Livelihood Promotion Company.
 - f) Sellers whose qualifications have been verified under Vendor Assessment by GeM Vendor Assessment Agencies for the Primary Product/Service tendered.
 - g) OEMs or direct service providers with annual turnover of INR 500 crore or more, as per GeM guidelines.
 - h) Sellers/Service Providers having valid BIS licenses listed in the BIS database, as per GeM guidelines.

B. Earnest Money Deposit (EMD):

For bidders other than those eligible for exemption above, the EMD shall be **3% of the estimated total tender value**. This rule also applies to purchases made through GeM.

Security Deposit

In the tender process, the following security deposit applies to the L-1 bidder (lowest bidder). The same rule applies as Performance Security/e-PBG for GeM:

- a) For enterprises/organizations exempted from EMD:
 - Purchases up to ₹5 lakh: exempt from EMD.
 - Purchases above ₹5 lakh: must submit a security deposit of **3% of the order value**.
- b) All other enterprises must submit a security deposit of **5% of the order value**.

Procurement from Startups

- a) Startups recognized under the DPIIT Startup India program and having Udyam registration and CSPO or NSIC registration:
- b) Such startups will be exempt from requirements of prior experience and mini

mum turnover, provided they meet the above eligibility. However, their annual production capacity must be **twice the tendered quantity**.

- This relaxation is **not available** to startups participating as resellers/traders.

CSPO registration will be issued within 15 working days.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
