1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 3. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 7. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
8. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. 9. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. All documents to stamped, signed and upload with the bid.

2. Items will be inspected by the BOO, in case, the items orders on receipt or not found to be confirming to the laid down specification, these items will be removed and replaced by the terms of contract with 30 days at own expenses.
3. Payment will be made after acceptance of stores.
4. If the uploaded documents are not readable the seller will be disqualified.
5. Bidder may be rejected at any time in the bid process, if any wrong documents/ Information found.
6. Availability of Service Centre : Bidder/ OEM must have a Functional Service Centre within 5KM of Consignee Location in case of carry in warranty . (Not applicable in case of goods having on site warranty). If service centre is not already there at the time of bidding, Successful bidder/ OEM Shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having functional service Centre. Certificate in this respect stating the address of the authorized service center be submitted at the time of technical evaluation.
7. Bidder Shall have to submit 04 x Sample (01 for each type) for approval from buyer before the bid end date failing which bidder will be disqualified during Technical Evaluation.
8. The vendor provide an escalation matrix with contact details at three levels : Local, Regional & national, to ensure prompt resolution of issues.
9. Pre installed software clause for Laptop

Genuine Operating System: The laptop offered must cum pre installed with a Genuine, licensed version of the latest supported Microsoft Windows Operating System (e.g., Windows 10 Pro, 11 Home & 11 Pro, as specified in the bid). The vendor shall provide proof of valid licensing and activation certificate for all the licensed software pre installed on the devices.

Microsoft Office Suit : The laptops must be pre installed with a genuine, licensed version of Microsoft Office Suite (e.g, Microsoft Office 365 or Office 2019 Professional), as specified in the bid documents. The vendor shall ensure that the software is activated and licensed for use and shall provide relevant proof of Licensing or subscription.

Software License Transfer : The licenses for Windows OS and MS Office Suite supported with the Laptop must be legally transferable to the buyer, with all associated users right as per Microsoft Licensing Policies.
