**Introduction:**

BPCL has always been a socially responsible corporation and has actively contributed to nation building th

rough its CSR activities for decades. With effect to amendments to CSR Rules, it has been made mandatory to conduct impact assessment through an independent agency for projects where the outlay have been more than Rs 1 Cr.

List of 21 Projects (**Annexure 1**) has been identified for conducting a impact assessment through external agency with the main objective of measuring the effectiveness of CSR activities that were implemented, it's significant of changes, sustainability & approaches of activities and contribution to the society at large. Project wise detailed scope of work is attached as **Annexure 2**.

**Terms & Conditions:**

-

- Bidder should consider the scope of work as mentioned in **Annexure-2**.
- The contract will be awarded to the bidder on an overall L1 basis.
- The bidder should quote for all the 21 projects and execute all the same as per the scope of work mentioned. Bidders will submit the at least 4nos. digital photographs of all activities in digital drive and hard copy (10x15 cm).
- The tender is only for empanelled vendors registered for Impact Assessment with BPCL CSR department.
- On award of job, the assessment agency should complete all the listed jobs as per the scope and submit the report. Any coordination with the local agency or third party required for the completion of the job will be within the scope of the assessment agency.
- The bidder should quote the rates inclusive of all costs – travel, transportation, stay and meals. BPCL will not arrange any air/rail tickets, vehicles, hotel, and meals for the assessment team.
- No advance would be paid by BPCL.
- Payments towards the entire charges would be paid after successful completion of each project assessment, submission of report and satisfaction of BPCL.
- The duration of the contract will be 90 days from the issue of LOI to complete the Impact Assessment of all 21 projects mentioned in **Annexure 2**.

- The Impact Assessment should be done on site by means of visit and primary collection of data through tools (Q & A sessions, Focused Group Discussion (FGD), Physical Verification of Assets with asset capitalisation & expenses details v/s budget allocated.).

100% payment will be made within 30 days after the receipt of invoice along with the final approved report by BPCL.

**Security Deposit:**

To ensure performance of the contract and due discharge of the contractual obligations, the successful con

tractor will have to provide a security deposit of 5% of the basic value of the contract within 15 days from the receipt of LOA. This Security deposit may be furnished in the form of NEFT or an Account Payee Demand Draft payable to BPCL or Bank Guarantee in the prescribed format. In case of Bank Guarantee, the same shall be valid and remain in force till the contractual completion period (and with a claim period of six months thereafter).

### **Liquidated Damage:**

In case the contractor fails to complete the whole work within the stipulated period, he shall be liable to pay liquidated damages of 0.5% of the basic value of contract per week and or part thereof of the delay, subject to a maximum of 5% of the value of the contract.

## **अस्वीकरण/Disclaimer**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of

this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.**
