- 5. Technical Competence:** I/We possess the necessary tools, manpower, and logistics to service all 157 units simultaneously across both segments (Within and Outside Aligarh) as per the maintenance schedule.
- 6. No Post-Bid Claims:** I/We shall not request any price escalation or modification of terms due to a lack of awareness regarding site conditions, distance, or the duration of the contract.

**All-Inclusive Pricing Commitment:** I/We hereby confirm that the quoted price for both Segment A and Segment B includes all operational and capital expenses. This specifically covers:

**Logistics & Labor:** All costs for transporting, installing, and removing coolers.

- **Consumables:** Mandatory annual replacement of grass/pads and painting of all units before every summer season.
- **Repairs:** All costs for repairing or replacing defective parts (Motors, Pumps, etc.) or entire units if found beyond repair.
- **Total Liability:** We understand that no extra claims for spare parts, labor, or 'out-of-station' conveyance for the 114 coolers outside Aligarh will be entertained by the Department during

the 3-year contract period.

#### 4. Buyer Added Bid Specific SLA

Text Clause(s)

1. The security money will be refunded after the two months from the end of contract period. The security money will not attract any interest.

2. **Seasonal Basis for Adjustments:** For the purpose of any financial adjustments, the "Contract Year" shall be strictly considered as a **six (6) month operational season**. Consequently, if there is a requirement to increase or decrease the number of coolers, or if any deductions are made for service deficiencies:

- **Proportional Payment/Deduction:** All such calculations shall be based on the **6-month season** only, as the coolers are required for a single season per year.
- **No Off-Season Billing:** No payments or adjustments shall apply to the remaining six months of the calendar year when the coolers are not in operational use.
- **Fixed Seasonal Ceiling:** While the payment is based on a 6-month seasonal value, the bidder remains obligated to provide service for the entire duration of the summer (even if it extends beyond 6 months) without any additional payment beyond the fixed seasonal rate.

#### अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
