Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. **1. Special Terms and Conditions for Solar Road Studs**

1. This category is designated for the procurement of "Solar Road Studs". The category is "BID ONLY" and procurement will occur exclusively through the bidding process.
2. Buyers shall specify the exact requirements related to dimensions, maximum load, lighting time etc in the bid.
3. Buyers shall also provide the requirement with regards to fixing and installation of road studs in the bid.
4. Buyers shall specify the certifications and test reports requirements in the bid.
