1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. - 2) Bidders must be either the Original Equipment Manufacturer (OEM) of Growth Monitoring Devices—namely Stadiometer, Infantometer, Weighing Scale (Infant), and Weighing Scale (Mother and Child)—under POSHAN ABHIYAAN, or authorised distributors/dealers of such OEM(s) manufacturing these devices. Bidders/OEMs must note that Bidders must strictly adhere to the “one OEM, one offer” rule. Multiple bids from different dealers (Bidders) of the same OEM will be rejected straightaway without further evaluation.
- 3) A valid manufacturing licence held by the OEM, issued by the Department of Legal Metrology of the concerned State, shall be uploaded in the technical bid.
- 4) In case the bid is submitted by an authorised dealer, an OEM Authorisation Certificate (strictly as per Annexure I), addressed to the District Programme Officer and issued by the concerned OEM in favour of the Bidder, must be submitted in the Technical Bid, along with a copy of the OEM’s Manufacturing Licence. If the Bidder participates as the OEM, a Self-Certification (strictly as per Annexure I) shall be uploaded in place of the OEM Authorisation Certificate.
- 5) The details of the OEM/OEMs—name, designation, address, email ID, and contact number—shall be provided on the OEM’s letterhead for verification purposes.
- 6) The interested bidder and its OEM/OEMs shall possess valid GST registration and PAN. Copies of the GST Registration Certificate and PAN Card of the bidder as well as of its OEM/OEMs, shall be uploaded in the technical bid.
- 7) The minimum average annual financial turnover of the bidder during the last three financial years, i.e. FY 2022-23, 2023-24 & 2024-25, ending on 31 March, shall be as specified in the bid document. Documentary evidence in the form of certified audited balance sheets for the relevant periods or a certificate issued by a Chartered Accountant/Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the bidder has been constituted/incorporated for a period of less than three (3) years, the average annual turnover of the completed financial years subsequent to the date of constitution/incorporation shall be considered for this criterion.
- 8) The minimum average annual financial turnover of the OEM/OEMs of the offered product(s) during the last three financial years, i.e. FY 2022-23, 2023-24 & 2024-25, ending on 31 March, shall be as specified in the bid document. Documentary evidence in the form of certified audited balance sheets for the relevant periods or a certificate issued by a Chartered Accountant/Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution/incorporation of the OEM is less than three (3) years old, the average annual turnover of the completed financial years subsequent to the date of constitution/incorporation shall be considered for this criterion.
- 9) Copies of the Income Tax Returns (ITR), along with the audited Balance Sheets and Profit & Loss Statements of the bidder for the last three financial years, i.e. FY 2022-23, 2023-24 & 2024-25, shall be uploaded with the bid.
- 10) The OEM shall hold a valid BIS Licence for the weighing scale, conforming to IS 9281 (Part 3):1981, wherever applicable, and shall upload the same in the technical bid.
- 11) The OEM/Bidder shall possess a valid ISO 9001 certification accredited by the National Accreditation Board for Certification Bodies (NABCB) and shall be uploaded in the technical bid.
- 12) The bidders shall submit Model Approval Certificates issued by the Director of Legal Metrology, RRSL (Regional Reference Standards Laboratory) certificates, Type Test Reports, and valid Calibration Certificates for all four (04) GMD models, along with their technical bids.

13) The bidder shall upload in the Technical Bid a valid Test Certificate for all four Growth Monitoring Devices, issued by a testing laboratory accredited as per ISO/IEC 17025:2017 by NABL/IQAS for the relevant test parameters. The Test Certificate must explicitly confirm compliance with all specifications, dimensions, toxicity and material grade prescribed in this bid, and must include clear photographs of the actual tested samples of all four devices as an integral part of the test certificate to verify if actual testing was conducted. The bidder shall also upload the laboratory's accreditation certificate for verification purposes. The date of the Test Certificate shall not be older than 60 days from the date of publication of this bid.

14) The bidder/OEM shall provide an undertaking for warranty for a period of four (04) years from the date of supply, covering any manufacturing defects, quality defects, defective raw materials, or poor workmanship. The OEM shall hold a valid repair licence issued by the Legal Metrology Department and shall carry out repairs during the warranty period and CMC.

15) A soft copy of the Earnest Money Deposit (EMD), as specified in the GeM bid document, shall be submitted online through the GeM Portal ([www.gem.gov.in](http://www.gem.gov.in)). The original Demand Draft/Bank Guarantee shall also be submitted to the office of the bidding authority on or before the bid end date and time. Bidders are advised that MSE OEMs are not exempt from furnishing bid security. Failure to submit the bid security by any such bidder shall result in outright rejection of the technical bid.

16) To fulfil the Experience and Past Performance Criteria, the bidder or its OEM of the offered product(s)—either directly or through authorised reseller(s)—shall have regularly manufactured and supplied the same or similar category products for a cumulative quantity of at least 1,000 devices to any Central Government / State Government organisation / PSU in any one of the last three (03) years.

17) A Net Worth Certificate issued by a Chartered Accountant for the bidder and its OEM/OEMs, certifying that the net worth is positive in the last financial year, shall be submitted along with the technical bid.

18) Annual GSTR-9 returns of the bidder for the latest financial year, i.e. FY 2024-25, as applicable, shall be submitted along with the technical bid.

19) Affidavits from both the bidder and its OEM/OEMs, executed on non-judicial stamp paper of at least Rs. 100/- and duly attested by a First Class Magistrate, shall be submitted along with the technical bid. The affidavits shall declare that neither the bidder nor its OEM/OEMs have ever been suspended/blacklisted, or disqualified by any Buyer Organisation, State Government, Union Territory, PSU, Central Government, or any other Government organisation for non-performance of contractual obligations, violations, formation of a cartel during the bidding process by using same IP address, or breach of any statutory Acts and laws.

20) The bidder shall hold and maintain a valid and active Dealer's Licence, issued in the name of the bidder by the Controller of Legal Metrology of the concerned State, for weights and measuring instruments, in accordance with the State Legal Metrology (Enforcement) Rules, 2011 and the Legal Metrology (Enforcement) Rules, 2010.

21) The complete GeM bid, when submitted on behalf of a firm, shall be signed by a person duly authorised through a Power of Attorney to do so. In the case of a company, the bid shall be executed in accordance with the provisions of the company's Articles of Association. The signatures affixed on the bid documents shall be deemed to be those of the authorised signatory. Power of Attorney / Authorisation Certificate / Board Resolution, as applicable, shall be enclosed with the bid.

22) The Bidder and OEM shall furnish an undertaking confirming their responsibility to comply with all applicable State and Central laws, rules, and regulations. Any subsequent amendments, modifications, or additions to such laws, rules, or regulations shall be equally binding on both the Bidder and the OEM.

- p) Jurisdiction: The courts of the concerned district in Punjab, where the GeM bid inviting authority is located, shall have exclusive jurisdiction over any disputes arising out of the GeM bidding process or in connection with this contract.
