1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. PRE-QUALIFICATION CRITERIA (PQ)

- i. GST Registration of the vendor should be from the State of Kerala. (GSTIN beginning with the numerals 32)
- ii. The service provider should have a registered office in Kerala and a local office at Ernakulam District of Kerala State against which documentary proof needs to be submitted for qualifying the bid.
- iii. All proofs sought in the ATC shall be compiled into a single document titled **“Related Documents.”** The documents must be scanned and arranged in the same order as specified in the ATC. Failure

re to submit the documents in the prescribed manner will result in the quotation not being fully scrutinized, and at the stage of variation, such quotation shall be liable to rejection.

## 2. Scope of Work

- i. **Cochin Special Economic Zone Authority intends to hire a dedicated premium SUV (Innova Crysta) with the following specifications for the official use of the Chairperson on a 24x7 basis for a period of two years.**

- a) CSEZ shall reimburse Parking charges/ any other statutory levies on production to proof thereof duly certified by the Officer in charge of the vehicle.
- b) The vehicle should be neat, clean and free from offences. The agency should present the vehicle for inspection before executing the contract.
- c) In the event of the non-availability, breakdown, maintenance, or any other absence of the vehicle provided under this contract, the service provider shall ensure the immediate deployment of a substitute vehicle of the same make, model, and specifications, without any additional cost to the Authority. The substitute vehicle shall be provided on a 27 x 7 (Without Fuel and Without Driver) variant and shall meet all the terms and conditions stipulated in this agreement.

### 3.0 PERIOD OF CONTRACT / CANCELLATION OF CONTRACT

- i. The period of contract shall be initially for two years from the date of the issue of the work order, and it is extendable by one year subject to satisfactory performance by the supplier.
- ii. The tentative start date of the contract shall be 01.04.2026 or upon completion of the selection of the service provider through GeM and issuance of the work order, as decided by the Competent Authority.
- iii. Chairperson, CSEZ Authority reserves the right to terminate the contract at any time without assigning any reason, for which no compensation shall be paid. **The actual period of contract starts from the date of receipt of Work Order.**

#### 4.0 **PAYMENT TERMS**

- a) Payment will be released within 30 days on submission of bill duly certified by the Officer-in-Charge.
- b) Services provided to a Special Economic Zone Developer are exempt from payment of GST. Accordingly, the qualified service provider shall execute a valid Letter of Undertaking (LUT) with the GST Department for availing GST exemption and shall comply with all applicable statutory requirements in this regard.

#### 5. **SPECIAL CONDITIONS OF CONTRACT (SCOC) - II**

##### a. Insurance:

The vehicle supplied for hire should possess valid Comprehensive Insurance to cover entire risks.

##### b. Motor Vehicle Tax , Fitness And Permit

The vehicle should have valid documents for the following, which should be paid for and updated by the service provider during the currency of contract:

- a) Registration Certificate
- b) Motor vehicle tax
- c) Fast tag
- d) Comprehensive Insurance policy
- e) Fitness certificate.
- f) Pollution Under Control certificate (PUC)
- g) Taxi permit/license

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.**
